#### Compatriots,

The Sons of Revolutionary Sires, founded in San Francisco on July 4, 1876, started this great organization. That spark led to the formation of the National Society Sons of the American Revolution on April 30, 1889. Since the very beginning the California Society has been the creative energy of the SAR and has nearly 125 years of achievements. Just look back ten months to the outstanding 2019 National Congress held in July at the Hilton Costa Mesa. The team of John Dodd, Kent Gregory, and a supporting cast of nearly 100 did an awesome job. The feedback was outstanding. It just goes to show that if we set a goal, apply ourselves, and have a great plan, we can accomplish anything.

For those of you who do not know me, I grew up on a 4th generation family farm in Michigan. My Great Grandfather was a 1<sup>st</sup> Lt. Regimental Quartermaster for the Indiana 12<sup>th</sup> Calvary. The large family home my Grandfather built around 1910 was destroyed in a fire in the early 1920's. Dad left the farm and worked

for Ford Motor Company during WWII but by time my two sisters and I came along we'd moved back to the farm and were raised in a small farmhouse and, yes, with an outhouse.

We eventually moved into town, population 9,000. I got a paper route, took up sports, went to Michigan State University, graduated, married my dear wife Mary Ann, joined Ford Motor Company and started traveling the USA – Seattle, San Francisco, Los Angeles, Houston and Tampa. During that stretch, I earned a Masters Degree in Business. Later, I joined a start-up in San Francisco leasing freight railcars, led 3 federal regulatory battles, won, and became President of the company. Following purchase by GE Capital, I left. I became involved with something called the internet in 1994, joined Intel in 1998, where I retired nearly 20 years later. All great jobs, working with smart people.

In 1976, on our nation's 200<sup>th</sup> anniversary, I was communicating with the Michigan Society to join the SAR but a job transfer to San Francisco interrupted filing that application. Thirty years later, my application to join the SAR was approved in February 2007, along with my son's. I have served the Sacramento Chapter as President in 2010, 11, 17, & 18, Treasurer since 2007, and our Executive Committee since 2010. I've helped with JROTC award ceremonies and Eagle Scout Courts of Honor. I have been involved with the Americanism Poster Contest since 2008 and in recent years the many Color Guard activities of the Sacramento Chapter. When the California Society needed a Wreaths Across America Chairman in 2010, I took on that role. None of that would have happened without the mentoring and steady encouragement of Tom Chilton, my dear friend and sponsor.

What defines the California Society? We are creators. We are committed. We are doers. The COVID-19 pandemic will take many more months to fully play out and extract an even greater toll. The SAR infrastructure and headquarters is mostly shut down. New member applications and processing are taking longer and you can expect delays. The SAR Store has suspended taking and shipping orders. Youth and public service awards and recognition are being disrupted. Government orders and continued social distancing will make our ability to lock arms, shake hands, and hold large gatherings difficult if not impossible.

In the meantime, we compatriots need to raise our heads, lift our eyes, and forge a path forward. One of the great motivational speeches I've viewed was delivered to the University of Texas 2014 Graduating Class by U.S. Navy Admiral William H. McRaven. 1. Start each day with a task completed. 2. Find a mentor. 3. Respect everyone. 4. Life isn't fair so keep moving forward. 5. Don't be afraid of failure. 6. Take risks. 7. When times are tough, step up. 8. Confront adversity. 9. Never lose hope, never give up. 10. Succeed.

If we commit ourselves to these ten items, together, we can steer the California Society through this challenging time and become better and stronger in the process. It will be our legacy to the future.

# Secretary's Report

The winter months are now a figment of our imagination, and summer is just around the corner and hopefully we all will have a much brighter summer than we did winter as the nation begins its long slow process of recovery. The surgeon general of the United States has said the pandemic will leave a lasting memory on the hearts and minds every American citizen and I know that is true for me and my family. It is my sincere prayer that you and your family were not affected by this national pandemic.

The California Society truly made a historic and bold move into the future when they held their 145<sup>th</sup> Annual Spring Membership Meeting via a Teleconference. This was a chance for many members to see first-hand the mechanism of the State Society and why the reports that are requested become so important to the society.

With the reporting season that has just passed, I would like to review the lessons learned from this past year and the Reconciliation Report and some of the difficulties that were encountered, both from the perspective of the chapters and that of the state society.

Many of the chapters began their dues campaign in late December, which doesn't give our membership adequate time to pay their dues, thus creating two problems; (1) the chapters are still collecting dues well into January when the Reconciliation Report is due to the State Secretary and (2) the chapters do not have adequate time to prepare the cumbersome Reconciliation Report and they find themselves having to submit multiple revisions because (a) they are continuing to collect dues and (b) they rushed to complete the report only to find errors after taking the time to review the report. As we are ushering the month of May the state Treasurer, the state secretary and the trustees are still trying to balance the books as a result of this year's results of the reconciliation reports that were submitted.

This past year, chapters dropped members that had paid dues, chapters paid dues for deceased members, life members that had been deceased for a few years were reported as active, and dues for members who had dropped their membership in previous years were paid. Members that had transferred into the society were not recorded on many of the reports. Several chapters failed to report their life membership accurately. These are just a few of the issues we as a society encountered this past year when trying to reconcile our membership. Dual membership still eludes us as a society and is something we need to work on for this coming year.

The importance of an accurate membership roster determines the number of delegates that California has to represent our state at the National Congress each year. This is important to each of us as member since at the National Congress many decisions are made on the national budget and how the money is spent.

The California Society has implemented into its bylaws, that each chapter should end the collection of dues on December 15<sup>th</sup> of each year and any member that has not paid their dues on or before the December 15<sup>th</sup> date shall be delinquent and shall be dropped from the membership roster for the coming year.

This seems to be a rather harsh and bold statement for the State Society to make; however, there is a sound rational for this bylaw. Ending the dues campaign on December 15<sup>th</sup> gives the chapter secretary the necessary time to prepare the chapters Reconciliation Report, to review the report and send the chapter's treasurer a note of the amount of dues that will be expected to be paid for the coming years dues, thus allowing the chapter to be able to close out their financial account by December 31<sup>st</sup> of the year for reporting purposes. It should be noted that the financial year for the Sons of the American Revolution is from January 1st to December 31<sup>st</sup> of each calendar year.

When the Reconciliation Reports are not filed on time, the California Society is essentially on hold and no transactions take place until the State Society can reconcile the State's membership with the NSSAR data base. The California State Society must have a clean roster as of January 1<sup>st</sup> of the new year with no pending transactions to ensure that we have an accurate accounting of all transaction that have been recorded in the National Data Base.

Once the California Society Reconciliation Report is in progress, all other transactions cease until the report is filled with NSSAR. This means that no reinstatements are processed, no transfers are processed, no new members applications are sent out and the supplemental applications are held until the Reconciliation Reports is completed and sent to National. Late Reconciliation Reports hurt all of our membership for these reasons.

Reconciling the states numbers with NSSAR requires hours of going back and forth over each of the state's records and the reports that each chapter filed with the state. This past year the CASSAR Reconciliation Report took more than 80 hours reviewing the states report against the chapters report and comparing to the NSSAR data base and there were still eight (8) errors made when the final report was filled, the process is tedious and extremely time consuming.

Once the final membership report has been reconciled, then there is the financial portion of the report which has to be reconciled. This process takes another 50 to 60 hours going back and forth over the chapter records. All the regular members have to accounted for financially, the junior members have to accounted for, the life members, ect. What the state reports to National and what is reported on the chapter reconciliation reports to the state do not always agree, as was the case this past year.

This past year, the chapters reconciliation reports agreed on the reconciliation reports filed; however, the numbers did not agree when all of the members were tabulated. The state society was off by thirteen (13) regular member when tabulated against the financial statement. After days of reviewing the California Society's Reconciliation Report, and running several analyses, CASSAR was able send NSSAR the final payment for our dues in mid-March.

The California Society has until January 31<sup>st</sup> of each year to submit their Reconciliation Report to NSSAR, this year, two chapters did not submit their reports to the California Secretary until the last week in January, making it impossible to compile with the NSSAR January 31<sup>st</sup> deadline, thereby pushing the reconciliation of the membership and the payment of the California dues to national and for the state to resume normal business of processing new member applications, transfers, deaths notices and reinstatements into February.

While it makes for more work for both the chapter secretary and the California State Secretary to reinstate a member, it is necessary to cease accepting dues on December 15<sup>th</sup> of each year and to file the chapters Reconciliation Report by the January 5<sup>th</sup> deadline, the date that is published in the California Society's bylaws for reasons mentioned.

It is the recommendation of the California State Secretary that every chapter should begin their dues campaign by October 15<sup>th</sup> of the year and end precisely on December 15<sup>th</sup> of the same year. This will give secretaries at every level adequate time to complete the necessary reports.

The Reconciliation Report is not the only report that chapter secretaries have to file in January. On or before January 15<sup>th</sup> each chapter is required to file the annual Change of Managers report to the state secretary. This report triggers National and the state to publish the names on the various web sites and to give the chapter secretary access to the National data base for the chapter's membership.

When we move into February, the chapter secretary needs to file the annual chapter reports for the CASSAR Annual Report, AKA, "The BOOK." The for the annual Spring Conference the chapter secretary needs to file the chapter delegates with the California State Secretary 30 days in advance of the meeting. Winter and spring is an active time for the state and the chapter secretary.

Published in the Compatriot is a section called the Secretary's Corner, this section has been provided for each chapter secretary to copy and use for the typical transactions that are completed by the secretary and the documents that are required to be submitted when the events occur. Please use the section and become familiar with the NSSAR web site and where to find the forms.

Please remember that I am always available either by phone or email to assist the chapters.

## California Society SAR Surgeon's Tent

We have learned a lot about terms like pandemic, mitigation and quarantines over the past couple of months, probably more than we want to know. And while our colonial ancestors may have experienced similar epidemics

As it gets close to two months of sheltering-in-place, we Californians should take a few moments to congratulate ourselves on "flattening the curve" with respects to COVID-19. By almost every measurement, we have succeeded in doing everything our leaders asked of us. We have sacrificed by giving up our freedoms, our jobs and happiness. And we've saved the lives of possibly tens of thousands of our fellow Californians while buying time for our health care system to build capacity and start developing new treatments.

Governor Newsom has laid out a Four Stage Plan to get Californians out of quarantine and back to work. Stage I is where we are now, at home flattening the curve and expanding hospital capacity. In our Allergy clinic, Stage I means that we are working on making our essential workplaces as safe as possible and expanding access to routine medical care. This includes the resumption of what were previously deemed "non-essential" surgeries. Many clinics are looking to open the week of May 4<sup>th</sup> or May 11<sup>th</sup>.

**Stage II** applies to the opening of lower risk workplaces with adaptations. These industries will include: retail with curbside pick-up, manufacturing, and offices when telework is not possible. Stage II includes opening more public spaces such as parks and recreational areas.

**Stage III** refers to gradually re-open "higher risk" workplaces, also with adaptations. Businesses under Stage III will pertain to personal care companies (hair & nail salons, gyms, etc.), movie theaters, sports without live audiences and inperson religious services.

**Stage IV** will mean that we're done with stay-at-home orders and we'll see the opening of the highest risk workplaces like concerts, conventions and live audience sporting events.

The Governor gives no specific dates for these re-openings to occur but notes they could take months if not years. And he promises that "our stores will look different. Our offices will operate differently. But we'll be healthier."

So, what adaptations could help us reduce the spread of SARS-CoV-2 or other viruses? These include touchless entry ways into buildings, the type of automatic doors already seen in many businesses. Health care clinics are developing "virtual waiting rooms," where patients remain in their cars or outside the clinic until they are called in and are quickly brought back to a patient room. You will also seem a greater attention to thorough cleaning of shared furniture, touch pads, etc. Expect to see touchless pay systems like Apple Pay, Venmo, CashApp, etc. favored over cash interactions. Regardless of the industry, we're likely to see fundamental changes in how we interact and do business in the short term.

That doesn't mean we're out of the woods yet. Remember, mitigation was designed to flatten the curve. But with novel viruses, it will take 45-70% of the population to have herd immunity before we can rest easy. That will either come from vaccination, which is years away, or via natural infections of hundreds of millions of Americans, which could potentially mean tens of thousands more deaths. Another hopeful area could be the development of pharmaceutical agents that could treat our sickest until a vaccine might be developed.

But we still need to be realistic about our own risks, not only our own personal health risks but also the risks involved with continuing to shelter-in-place in terms of lost income, affects on mental health, etc.

There hasn't been a pandemic like this in quite some time. Our ancestors experienced multiple shorter epidemics, but they also lived through much more deadly outbreaks, from cholera, yellow fever, smallpox and plague. We worry about giving Bill Gates immunity from prosecution for rushing a CoV2 vaccine to market when inoculation to smallpox once carried with it a 5-8% mortality rate. And Washington inoculated the entire Continental Army against smallpox understanding that risk. The Black Death killed an estimated 30-60% of Europe's population at the time, upwards of 125M people. Even the 1918 Spanish Flu killed 50M people across the globe.

While we may not sometimes see it, we're blessed to have been born into a relatively rich country and world that has been able to sink huge amounts of resources into understanding every aspect of this novel disease. And we've made a great deal of progress in a very short period of time. I have no doubt that by the time you read this, we'll know even more. So, let's revive that American can-do spirit we were always known for and not let anything get in our way of creating a safer, more prosperous and freer America in the future. Our ancestors who fought in the Revolution would expect nothing less.

## 250th Anniversary Challenge Coin



#### 250th Anniversary of the American Revolution Recognition Program

The recognition program is designed to encourage and recognize those compatriots, chapters and societies that participate in local, state, national and international events which publicly educate, and recognize, honor, and celebrate the events and heroes of the period surrounding the American Revolution. Participation involves the planning and execution of these events, as well as attendance. The medal covers the celebration of any event's 250th anniversary where said event related directly to acts of resistance to British attempts to coerce the residents in America: from the first Parliamentary Acts protested after the conclusion of the Treaty of Paris by the Continental Congress. This therefore will cover any public celebrations in the period from 2014 to 2033. Form may be submitted to cover multiple years and following the first submission be submitted in multiple years, only covering activities since the previous submission. Scorekeeping is the responsibility of each compatriot and awarding authority. You will receive an email authorizing the purchase from merchandising.

## President General's Education Outreach Streamer

The requirement to receive the President General's Education Outreach Streamer is for compatriots of a chapter to do a certain number of new Historical Presentations or to present an existing presentation in a new venue or to a new audience. Examples of Historical Presentations would be speaking on a Revolutionary War Battle or Campaign; a significant Personality or Founding Father; a political event or process; life as a soldier (uniforms, weapons, camp life, etc.); life as a colonist (clothing, money, community and religion, etc.); life on the frontier (clothing, Native American relations, living conditions, etc.); life as an indentured servant or as a slave; period flags; period music, etc. It should be left to the chapter Education Team Leader and the State Education Outreach Coordinator to make the call on what constitutes an appropriate presentation.

A new venue or audience is just that. If you have a presentation you have done for your chapter and go do it for another chapter, the local DAR Chapter, or the Lions Club those are new venues. If you have a program you do for the local 5<sup>th</sup> Grade Class every year, then that is a new audience every year.

The number of presentations required is based on the size of the chapter. The larger the chapter the more presentations required to earn the streamer. The reason is that a larger chapter has more compatriots who can give presentations and therefore more opportunities than the smaller chapters.

The objective of the PG's Program is to recognize those chapters who are taking education outreach to the American people and raising the profile of the SAR in their communities.

#### **Program Streamer Requirements:**

Chapter with less than 41 Members: 3 Presentations Chapters with 41 to 80 Members: 4 Presentations Chapters with 81 to 120 Members: 5 Presentations Chapters with more than 120 Members: 7 Presentations The reporting period is June 1<sup>st</sup> to May 31st annually (a "Congress Year").

# 145th Annual Meetíng of the Membershíp



Due to the Wuhan Virus pandemic and the current quarantine orders in California, the 145th Annual Meeting of the California Society was held electronically on April 18, 2020 by Zoom Meeting. President Robert Taylor opened the meeting at 9 AM, with the normal opening rituals. There were about 75 participants on the Zoom Meeting.

Secretary Fred Schuster held a roll call of the state officers and chapter delegates. CASSAR Officers attending were President Robert Taylor, Executive Vice President Don Littlefield, Vice President North Craig Anderson, Vice President South Brian Stephens, Vice President Membership Doug Bergtholdt, Secretary Fred Schuster, Treasurer Jim Klingler, Registrar Owen Stiles, Chancellor John Dodd, Historian Jim Blauer, Chaplain Lou Carlson, Surgeon Matthew Bowdish, Invested Funds Trustee Stephen Renouf, Invested Funds Trustee Kent Gregory, and Immediate Past President Derek Brown. Chapter presidents attending were Steve Scully (Central Coast), David



Grinnell (representing Coachella Valley president), Melvin Howe (Delta), William Fredericks (Eagle), Thomas Shaw (General Patton), Ron Barker (Gold Country), Brandon Villardi (Harbor), Michael Davis (Kern), Jack Francke (Monterey Bay), Kevin Tierney (representing Mother Lode president), Daniel McKelvie (Orange County), Shawn Price (Redlands), Bill Van Valkenberg (Redwood Empire), Rob Dickey (Riverside), William Peters (San Diego), Jeffrey Wienbender (Santa Barbara), Terry Briggs (representing Silicon Valley), Tom Perkins (Sons of Liberty), Robert Whitman (South Coast), Gregory Owens (Thomas Jefferson), and Bob Hendon (Yosemite). President Robert Taylor declared a quorum. President Taylor acknowledged guests, including PG Joe Dooley of Virginia, VPG James Fosdyck, and NSSAR Trustee for California Derek Brown.

Chancellor John Dodd presented two Bylaws Proposals for the Bylaws committee, and both were recommended by the committee. He presented Proposal #2 (Bylaw 8, Section 1) to insert a new subsection (i) to authorize hold-



ing an electronic meeting using language from the NSSAR bylaws. Proposal #2 was approved by a voice vote of chapter presidents unanimously. Chancellor Dodd presented Bylaws Proposals #3 (Bylaw 8, Section 1) to inset a new subsection (j) to permit the executive committee to change the time and location of all CASSAR meetings by a 2/3 vote of the executive committee. Proposal #3 was approved by a voice vote of chapter presidents unanimously. The bylaws amendments take effect upon passage, so the current meeting was officially authorized. President Taylor asked for ratification of the March 21, 2020 Executive Committee action cancelling the physical meeting in Rancho Murrieta and replacing it with the electronic meeting on Zoom. The action was ratified by a unanimous vote of the officers and delegates. The previous annual meeting minutes from April 2019, and the board of managers meeting minutes from November 2019 were approved unanimously.

President Taylor addressed the meeting, and he noted the challenges of the Wuhan Virus pandemic. He acknowledged Past President Oliver Everette of the Thomas Jefferson Chapter was critically ill. He had not heard of any members affected by the Wuhan Virus. He thanked everyone for their support during his term. The Wuhan Virus pandemic has presented many challenges to the state society, and we have quickly responded so we could continue to conduct business until the crisis passes.



The officer reports were published electronically in The Book, which was placed on the state website. Those with additional comments were able to speak. Secretary Fred Schuster recognized Stephen Renouf and Jim Faulkinbury for the record copy project, completing the CASSAR number Master List, and getting copies of missing applications for CASSAR numbers 0001-11064. NSSAR Trustee-California Derek Brown noted that Sarah Strapp-Dennison, the SAR Foundation Development Director, is leaving the SAR, and they are looking for a replacement. The NSSAR Bermuda Trip has been cancelled due to the pandemic. Chancellor John Dodd did not have a report in book, but has been busy with helping to set up the electronic meeting and dealing with the Rancho Murieta hotel. Genealogist General Jim Faulkinbury stated some work is being done with applications at National. States can now send applications again – anything that can be done remotely is being done. NSSAR is continuing to have 13 bound volumes of applications digitized, and PRS volunteers are looking at old records to get them transcribed. Chaplain Carlson, as head of the Ethics Committee, reported the successful resolution of a problem at the Sacramento Chapter. Investment Funds Trustees Stephen Renouf, John Dodd and Kent Gregory presented the trustees' report, noting that the total value of investments decreased over the last 12 months (ending February 29, 2020) by almost \$20k due to a \$16,700 withdrawal for the recent CASSAR donation to the SAR Foundation, and the stock market correction in February 2020. The committee recommended changing the Risk Factor (1-lowest, 5 -highest) for the Life Membership and Education Funds from 3 to 4, keeping the risk factor at 4 for the Permanent and the Congress Fund at 4, and changing the risk factor for the Unallocated Fund from 2 to 3. It was recommended to give the Advisor discretion as to when to adopt these changes due to the current volatility in the market. The recommendation was passed by a voice vote of the officers and chapter delegates with one nay vote.

CASSAR Color Guard Commander Kramer announced the Best Chapter Color Guards were: Orange County (very large chapter), General Patton (large chapter), Harbor (medium large chapter), Delta (medium small chapter), and there were no entries for small chapters. He awarded Silver Color Guard Medals to Mark Torres (Orange County), Matthew Noell (Orange County), Larry Hansen (Orange County), and Brian Merrell (Harbor). The CASSAR Color Guardsman of the Year was Larry Hansen (Orange County).

CASSAR Best Chapter Contest Chairman Doug Bergtholdt reported the winners for 2019-20: Orange County (very large chapter), Riverside (large chapter), Kern (medium large chapter), Redwood Empire (medium small chapter), and Delta (small chapter). Chairman Bergtholdt noted that CASSAR has to replace some of the plaques



as they are getting full. Brian Stephens announced that CASSAR qualified for the NSSAR Furlong Award for chapters participating in the Flag Certificate Program. Additionally, CASSAR had two chapters report they presented the new SAR Flag Retirement Certificates. VPG Fosdyck announced CASSAR may win the NSSAR Walter "Buck" Meek Award for the state society having the most new George Washington Fellows: California had 30 new fellows. Chairman Lou Carlson reported on the 250th Anniversary Committee – Jim Blauer is making a list of events to celebrate for the 250th Anniversary of Revolutionary War Era events. Lou Carlson encouraged chapters to celebrate events as part of the program.

Chapter Reports were received from all chapters except Santa

Barbara and San Francisco. Bob Ebert reported on the San Francisco Chapter. Secretary Fred Schuster sent out a template to all the chapters. Santa Barbara said they would send their report by e-mail to Secretary Schuster. Chancellor Dodd noted some chapters were missing required information from their reports, including financial information, which is required by law, so we need to have the chapters fully complete their reports. He also noted that as a 501(c)(3) tax exempt organization, the SAR needs to do something with our money to comply with this status. He recommended all chapters do historical, educations, and patriotic works with their money rather than simply accumulating it.

After a 10-minute recess, Treasurer Jim Klingler described the new procedure for the audit committee. The audits are done every year at the state meetings, but this year it had to be done electronically. Members of the audit committee requested random deposits and payments from the treasurer, who sent them out to the committee. Chairman Don Littlefield noted that everything was found to be in order.

Under old business, the DAR Award was discussed. SAR Medals are given to DAR members for providing SAR applicants who are subsequently approved. There was a motion by Brian Stephens for CASSAR to additionally give a \$100 cash



award to the DAR chapter that provides the highest number of approved SAR applications (if greater than 5), and added to the DAR liaison budget, effective 2020 calendar year. The motion was passed unanimously.

Genealogist General Jim Faulkinbury gave an update on the CASSAR dues collection proposal. He said since NSSAR has its own plan, he is dropping the state proposal. CASSAR is a test group for the NSSAR program. President Taylor said the CAR Liaison needed to request a check to be send to the CAR for the year. Color Guard Commander Mark Kramer reported on liability and black powder insurance. He said NSSAR now has a national safety procedure (covering insurance and training requirements), and he commended John Dodd for working behind the scenes to get it established. Commander Kramer said he would get the national policy posted to the state website.

Under new business, John Dodd presented Bylaws Proposal #1 (Bylaw 2, section 6), which was recommended by the Bylaws Committee. It would remove the CASSAR Ladies Auxiliary from the CASSAR Bylaws. The Ladies Auxiliary is a separate, chartered entity, which CASSAR does not control. They are also considering eliminating their liability insurance.

Currently, the Ladies Auxiliary is in the CASSAR bylaws under "chapters," but it is NOT a chapter. When the Ladies Auxiliary was created, the first president, Linda Moran, insisted that it be included in the CASSAR Bylaws, so it was added many years ago. There was an amendment to have the Ladies Auxiliary language in section 6 removed from Bylaw 2, and made its own Bylaw (new Bylaw 10), which was approved by the chapter presidents with one nay vote. The motion as amended was then approved with one nay vote. John Dodd encouraged all members to get their wives, daughters, etc. to join the Ladies Auxiliary. The Ladies Auxiliary is contemplating cancelling their liability insurance due to their declining membership.

There was a proposed Outstanding Sea Cadet Award proposal by Bill Nay. Many chapters present SAR Bronze Good Citizenship Medals to sea cadet programs; however, there is no state or national recognition for Sea Cadets.



Bill Nay made a motion to establish a CAS-SAR Outstanding Sea Cadet of the Year Award (with a cash prize of \$1,000), and to increase the Sea Cadet budget line item from \$200 to \$1500. This motion was unanimously approved. There was a motion to ratify the Executive Committee action which reduced the cost of the printed *California Compatriot* from \$45 to \$25, and it was approved unanimously. It was noted that a \$250 budget was established to pay for DAR Regent meals at CASSAR Meetings, and this information needs to be disseminated to chapters hosting state meetings.

Secretary Fred Schuster said he would be submitting an article for the upcoming *California Compatriot* on the problems being encountered in the reconciliation reports and reinstatements. There are a number of dual members, but they are not being reported correctly. He will need to have it reconciled in the next year's reconciliation. If a chapter has a dual member (primary in another state society), it needs to be reported and the state dues need to be paid for the dual member. Some chapters did not do a good job of indicating junior members – they need to be more careful next year. Incoming CASSAR President Donald Littlefield stated there will be a task force to deal with the reconciliation problems.

After a 10-minute break, Lou Carlson announced that the CASSAR Memorial Service would be deferred to the Fall Board of Managers Meeting. He did note the passing of Stanley G. Henderson, who served as CASSAR President in 2004-05. Registrar Owen Stiles noted the passing of General George Washington member Dale Ritter at age 100. Chapters need to send notices of member (active or inactive) deaths to the State Secretary, who will fill out the paperwork, and notify the State Chaplain, and the Treasurer/ Invested Funds Trustees.

The youth contest winners were announced: Chairman Dave Gillard announced there were 5 entries for the **Poster Contest**: the winners were: 1st place Sacramento (\$350), 2nd place Gold Country

(\$250), 3rd place Orange County (\$150), 4th place Harbor (\$100), and honorable mention San Diego (\$75). Chairman Kevin Tierney announced there were 53 submissions from 4 chapters for the **Brochure Contest**: the winners were: 1st place Orange County (\$400), 2nd place Sacramento (\$300), 3rd place Mother Lode (\$200), and 4th place Gold Country (\$100). Chairman Patrick Cecil was not present but submitted a report on the **Knight Essay Contest** – the winner was Anaida Haroutiunian of the Sons of Liberty Chapter, who will receive \$1,000. Her essay was entitled, "The Building Blocks: Lights, Camera, Action." Chairman John Ferris reported that the **Oration Contest** contestant deferred until next year. Chairman William Nay reported that the **CASSAR Eagle Scout Contest** winner was Michael McPhie of the Orange County Chapter, and he will receive \$1,000. His name was submitted to the National Socie-



ty, and he was selected as the 1st place winner of the **NSSAR Eagle Scout Contest**, and he will receive \$10,000. This is the first time that a California contestant has won the National Contest. Chairman Rob Dickey reported that there were four submissions for the **JROTC/ROTC Enhanced Essay Contest**, but two did not meet the requirements. Megan Lange (sponsored by Sacramento Chapter) won first place (\$1,000), and the contestant sponsored by the Orange County Chapter came in second place.

The public service winners were announced: The **Robert Burt Scout Volunteer Award** was awarded to Hans Hunt (Orange County), and William Crewe (Central Coast). They will be invited to the fall board of managers meeting to re-

ceive their awards. Robert Burt's widow, Trudy Burt, will present the awards if they are able to attend. The **SAR Law Enforcement Commendation Medal** was awarded to Detective Louis Cameron of the West Sacramento Police Department, who worked on several high profile, violent criminal investigations. The **SAR Heroism Medal** was awarded to Officer Scott Farnsworth and to Officer Chris Cobb of the West Sacramento Police Department, who saved the life of a six-year-old child with autism who had fallen into a reservoir. They dropped their equipment, and jumped into the reservoir and rescued the child. The **SAR Heroism Medal** was also awarded to

Deputy Brian Bell of the Sacramento County Sheriff's Department, who responded to an active shooter situation in which rookie police officer Tara O'Sullivan was ambushed and shot with a rifle by a career criminal during a domestic disturbance call. Deputy Bell gave his weapon to a fellow officer to provide cover fire, and risked his life to drag the wounded officer to shelter. Sadly, Officer O'Sullivan later died from her wounds.

The CASSAR Awards were announced: Chairman Brian Stephens announced a Certificate and Martha Washington Medal Oak Leaf Cluster was awarded to Linda Adams (Kern) for referring 21 new members. The California Society has qualified to receive the **NSSAR Admiral Furlong Award** for a majority of chapters participating in



the SAR Flag Certificate program. Chairman Kent Gregory announced the **CASSAR Richard F. Locke Award** for membership retention for 2019-20 was awarded to:

Sacramento (very large chapter), General Patton (large chapter), Kern (medium large chapter), and Yosemite (small chapter); there were no submissions in the medium small chapter category.

Outgoing CASSAR President Robert Taylor presented awards. He awarded the **SAR Patriot Medal**, the highest award a state society may present, to Daniel McKelvie, William Nay, and Ernest McCollough. He awarded the **SAR State Medal of Distinguished Service** to Dr. M. Kent Gregory. He awarded the **SAR Silver Roger Sherman Medal** to Donald Littlefield, Frederick Schuster, James Klingler, and James Fosdyck. He awarded the **SAR Daughters of Liberty Medal** to Anne-Doerte Epstude Adams, who has attended eight National Congresses, seven SAR Leadership meetings, and participated in the Ladies Auxiliary at 12 CASSAR meetings.

Her award was long overdue. The **SAR Lydia Darragh Medal** to Darian Taylor and the **Bronze Good Citizenship Medal** to Un Hui Fosdyck. He awarded **SAR Certificates of Appreciation** to Craig Anderson (VP-North), Brian Stephens (VP-South), Douglas Bergtholdt (VP-Membership), Owen Stiles (Registrar), John Dodd, Esq, (Chancellor), Terry Briggs (Genealogist), James Blauer (Historian), Rt. Rev Louis V. Carlson (Chaplain), Matthew Bowdish, MD (Surgeon), Stephen Renouf (Chairman, Invested Funds Trustee), Derek Brown (Immediate Past President), Benjamin O'Neal, Mark Kramer, Greg Hill, David Grinnell, David Gilliard, Ray Raser, Linn Malaznik, Luke Dziurzynski, Patrick Cecil, Rob Dickey, Brandon Villardi, Kevin Tierney, and John Ferris.

After a 5-minute break, John Dodd reported on the National Congress. He said the NSSAR Executive Committee was meeting weekly to discuss the upcoming National Congress in Richmond, Virginia. There will be an electronic Trustees Meeting on May 2, 2020 to discuss COVID-19 contingency plans, approval of grant applications for federal small business loans due to the crisis, and contingency plans for the upcoming National Congress in Richmond, Virginia. Due to the emergency, the NSSAR Trustees recently voted by e-mail 95-2 to delegate to the Executive Committee decision making power for the Richmond Congress. The

SAR Annual Congress Registration will be available in mid-May (money will be refunded if the Richmond Congress is cancelled). Compatriots should register for congress as if it will happen. The SAR cannot cancel with the hotel without *force majeure*. We do not yet know if any quarantine measures will be in effect in July that will allow us to cancel the hotel contract without the \$290k penalty. A decision will need to be made by the Executive Committee in early June. There are three possible choices to consider: 1) continue with Congress as scheduled (the hotel is currently behind in renovations work due to the emergency); 2) hold a Zoom Meeting for Congress (with Election Runner election service over a 24-hour period for officer elections), with reports in the book (and additional comments as necessary), and changing the election rules to allow candidates to speak prior to the nominating speeches;

or 3) hold a one-day meeting in Louisville with some physical meetings, and some electronic meetings. The California Society needs to report its 32 delegates to Congress by June 12, 2020. Please inform President Donald Littlefield by the end of May if you are going to Congress so he can select the CASSAR delegates.

Rob Dickey read the slate of CASSAR officers for 2020-21: President Donald Littlefield, Executive Vice President Brian Stephens, Vice President North Craig Anderson, Vice President South James Klingler, Vice President Membership (2020-22) Doug Bergtholdt, Secretary Fred Schuster, Treasurer John Ferris, Registrar Owen Stiles, Chancellor John Dodd, Genealogist Terry Briggs, Historian Jim Blauer,





Chaplain Lou Carlson, Surgeon Matthew Bowdish, Invested Funds Trustee Stephen Renouf (2020-23), Invested Funds Trustee Kent Gregory (2019-22), Invested Funds Trustee John Dodd (2018-21), and Immediate Past President Robert Taylor. Chairman Jim Fosdyck asked for nominations from floor, and there were none. The slate of officers was elected unanimously. VPG Jim Fosdyck installed new officers, and Genealogist General Jim Faulk-inbury installed Donald Littlefield as CASSAR President. Don's wife Maryanne Littlefield placed the CASSAR State President neck ribbon on President Littlefield.

#### **Thomas Jefferson Chapter**

February Speaker: Aurora Belarmino

The Thomas Jefferson Chapter met on February 15, 2020 at the Old Spaghetti Factory in Concord, California. Our speaker was Aurora Belarmino, a member of the Mt. Diablo Chapter, DAR. Aurora presented, "A Family of Trailblazers: From Vikings to Silicon Valley Girl." Her journey began with a story told by her brother, Lee Belarmino, Sr., a member of the Sons of the American Revolution. He told his son, Lee Jr., and his daughterin-law, Jill, that their grandfather told him a story about being in San Quentin. Jill Belarmino took it upon herself to research this story. In the process, she researched Aurora's maternal line leading to many interesting discoveries. She had three of her 9-great grandfathers who were founding ancestors – William Hilton of Suffolk, England, who arrived in the Plymouth Colony in 1621 on the *Fortune*, and was a founding settler of Dover, New Hampshire; Puritan Rev. John Maverick of Devon, England, who arrived in the Massachusetts Bay Colony in 1630 on the *Mary and John*; and Henry Kingsbury the Elder of Suffolk, England, who arrived in Salem, Massachusetts, in the Summer of 1630 on the *Winthrop Fleet*, and was a signer of the Boston City Charter. Over the centuries, her family fought in many wars in America – two Maine ancestors in King Philip's War (1675-1678), three Maine ancestors in King William's War (1688-1699), five Maine/Massachusetts ancestors in Queen Anne's War (1702-1713), one Maine ancestor in the Seven Years' War (1754-1763), two Maine/Massachusetts ancestors in the Revolutionary War (1775-1783), and one Maine ancestor in the Civil War (1861-1865).

Aurora noted that her 7th great aunt by marriage, Hannah Duston (1657-c.1737) was the first American woman honored with a statue (located in Boscawen, New Hampshire). During King William's War, Hannah Duston and her infant daughter were taken captive by the Abenaki Indians from Québec during the Raid on Haverhill in 1697. The Abenaki murdered her baby by smashing her head against a tree as the prisoners were taken to an island in the Merrimack River (now Boscawen, New Hampshire). She and two other prisoners used a hatchet to kill and scalp the Indians holding them hostage, and they escaped in a canoe back to Haverhill, traveling only at night to avoid recapture.

Aurora stated that her ancestors came from across the class spectrum. Her 10-great uncle, Samuel Maverick, became one of the first slave owners in New England in 1638. Her 7-great grandfather, John Smyth, became an indentured servant around 1640. Her 6-great grandfather, Robert Junkins, was captured by the English Army in the Battle of Dunbar in Scotland, and he was transported with 150 Scots to Massachusetts to be sold into indentured servitude. Her 7-great grandfather, Samuel Came, held the last slave in New England around 1760. She also had many notable distant relatives, including Lady Godiva, author Herman Melville; Quaker poet John Greenleaf Whittier; poet T. S. Elliot; playwright Tennessee Williams; Presidents James Garfield, Herbert Hoover, Gerald Ford, George H. W. Bush, and George W. Bush, and Vice President Eldridge Gerry. Her 10-great grandmother Mary Gye is her gateway ancestor for the lineage societies The Order of the Crown of Charlemagne, The Baronial Order of Magna Charta, and The Royal Bastards. Through Mary Gye she has many royal ancestors – Holy Roman Emperor Charlemagne, the Viking Count Rollo of Rouen, Count William I Longsword of Rouen, Duke Richard I the Fearless of Normandy, Duke Richard II the Good of Normandy, Duke Robert I the Magnificent of Normandy, King William the Conqueror, King Henry I of England, King Henry II of England, King John of England, and King Henry III of England.

Aurora then jumped forward 11 centuries to her grandfather, Edwin Lydston, who was born in Haverhill, Massachusetts, in 1891. At age 9, he entered the Chase Home for Children in New Hampshire, and graduated from grammar school at age 14. He was charged with public drunkenness at age 15 in Massachusetts. He became a machinist at Monroe Motor in Michigan, and got married at age 22 to Zoa Kilbourn, with whom he had three children, including Aurora's mother. At age 33, Edwin Lydston moved to Sacramento, California. Jill Belarmino was able to confirm the story that started the whole process. Yes, Grandpa had been in San Quentin. At age 34, he was convicted of burglary in the second degree, sentenced to San Quentin Prison, and paroled after a year in jail. His prison card noted he had a bullet wound in his left breast through to his left shoulder. Edwin Lydston died in Sacramento in 1974. Aurora's mother, Helen Lydston, married Filipino Andres Belarmino in 1941 in Boston, Massachusetts, and they had ten children. Helen and Andres were not able to legally get married in California due to anti-miscegenation laws.

## Remembering a Past State President

Stanley George Henderson died peacefully on February 20, 2020 at the age of 84, while in the company of his daughter. Stan is survived by his three children, Stanley M. Henderson, Kathryn Henderson and Paul Henderson (Gina Henderson), and his three grandchildren, Grant, Nolan and Sofia. He is preceded in death by his loving wife, Linda Henderson, father, George Wallace Henderson, his mother, Hazel Livina Everts, as well as his grandmother, Hazel Lilliana Lampman Everts, whom he was very close to. Stan was born in Victoria, British Columbia, Canada in 1935. He relocated to Butte County with his mother in 1946.



He also lived in Coeur d'Alene, Idaho, with his favorite uncle, Mark Everts. Stanley also lived in Claremore, Oklahoma, Oakland, California, Washington, and Oregon for short periods of his youth. Stan attended Durham High School and later obtained his GED. His first job was as a radio announcer at a local radio station. He attended National Guard Camp with plans to travel to Fort Benning, Georgia, for infantry training in early 1954. Stan subsequently joined the Army and became a Paratrooper in the 82nd Airborne. # George Washington Bids Farewell to His Officers

On November 25th, 1783 after eight years of war and more than six years of occupation New York was finally liberated from British control. The remaining American Army and officers paraded in and regained control physically demonstrating the end of the War for Independence. By the 4th of December General Washington was ready to depart from the Army and travel to Maryland where the Congress awaited his resignation as Commander in Chief of the Continental Army. Before he left, he had one last duty to perform, a gathering of his remaining officers one last time to say farewell. home in their lifetime and the odds were that after all the years of war and struggle they saw together he would never see these men again. The scene was described by Colonel Benjamin Talmadge in his memoirs.

At 12 o'clock the officers repaired to Fraunces Tavern in Pearl Street where General Washington had appointed to meet them and to take his final leave of them. We had been assembled but a few moments when his excellency entered the room. His emotions were too strong to be concealed which seemed to be reciprocated by every officer present. After partaking of a slight refreshment in almost breathless silence the General filled his glass with wine and turning to the officers said, 'With a heart full of love and gratitude I now take leave of you. I most devoutly wish that your latter days may be as prosperous and happy as your former ones have been glorious and honorable.

For the past three years Compatriot Daniel H. T. Shippey has had the opportunity and honor to portray General George Washington while recreating this event for visitors at Fraunces Tavern Museum in lower Manhattan. Compatriot Shippey said it's always a moving event to be a part of. After the toast Washington continued by saying, "I cannot come to each of you but shall feel obliged if each of you will come and take me by the hand." General Knox being the nearest to him turned to the Commander-in-chief who, suffused in tears, was incapable of utterance but grasped his hand when they embraced each other in silence. In the same affectionate manner, every officer in the room marched up and parted with his general in chief. As they conclude the performance portion of the event Compatriot Shippey moves to the gallery to shake hands with each person, looking them in the eye in silence and remembering what this moment had cost those men. Often there are tears.

Portraying General Washington is something Compatriot Shippey has done for a decade now. According to Compatriot Shippey, "If I should have the good fortune to return to Fraunces Tavern next year I will be the same age as Washington was when this event occurred. It is always an honor to stand in place for the General and I always work hard to make sure that I do everything in my power to bring his persona to the public. It's always my desire that people should walk away feeling they have encountered the man."

After a long time of not being able to talk about it, Compatriot Shippey can now say that he has signed a contract to study, expand and continue to develop his interpretation of General Washington with the good people of Mount Vernon. Dan will get to work during this year with a man whom he has long respected for what he has brought to this role, Mr. Dean Malissa. Dan said, "I'm very glad to finally be able to share this with my friends and fellow compatriots. We will be continuing to live in Southern California, and I will be commuting to work. This opportunity is a blessing, an honor, a challenge and an adventure."
