The President's Message

Compatriots, I am honored to have been elected as your President of the California Society for 2014-2015 and will serve you to the best of my ability. In my inaugural address, I told those present that, to me, the SAR holds a special place, worthy of my dedicated participation, because of the many programs and activities that we are involved in to fulfill the goals and objectives of our organization. We do a lot! In addition to the Center for Advancing America's Heritage, now nearing completion, we have many youth programs, supported from the chapter level on up to the National Society, all awarding prizes and scholarships to involve our youth in learning about the history and sacrifices of those patriots who fought for the independence of this great nation. We have Color Guards participating in patriotic holidays and events and serving as the public face of our society. We also have the great comradeship between our members. Looking back at our history, I can also say that we have played a significant role in many things over the last 125 years. This is an organization I want to be a part of!

I also noted in my address, that over the last several months, visiting chapters, and talking to their officers, that I have seen a need to not only to grow in membership, but to also grow in leadership. Like all volunteer organizations, most of our members are not actively involved in the various programs and activities that we support. Several Chapters are struggling to survive as they have a difficult time recruiting members to serve as chapter officers, committee chairmen or even committee members. Last year the CASSAR had an overall net gain of 64 members or 4% in membership after 238 new members offset those who decided to drop off of our rolls and

the loss of those compatriots that passed on. As I took the office of President, we had 1556 members. Yet many chapters are supported by the same individuals who have done so for several years. Those chapters that expressed the most difficulty in filling their leadership requirements have adequate membership numbers, but their officers and chairman are getting burnt out serving year after year to keep the chapters going. I encourage all of the members to reflect on their contributions to their chapters and to the California Society and to remember the oaths they took when they were first inducted into membership in the SAR; their pledge to

support the objectives of the Sons of the American Revolution. I encourage all members to take a more active role in their chapters, join or create a Color Guard, join a committee working on one of our youth programs, consider holding a chapter office. Get involved in this wonderful organization! We do serve an important role in our communities and our message needs to get out.

I also encourage those who are interested in seeing how our organization works to come to our State and National meetings. The National Congress this year will be in Greenville, South Carolina and, in addition to the business of the Society; there will be tours of some of the

JUNIOR MEMBERSHIP ADVANTAGES

- Junior members receive California and National member numbers that remain with them throughout their adult life.
- Junior member dues are significantly lower than regular member dues (see table next page).
- Junior members automatically become regular members after their 18th birthday simply by paying full dues, even if their membership lapsed during the intervening years.
- May join under the family plan mentioned above. Could also be eligible for the reduced fee when using an ac-ceptable, previously approved DAR or SAR application.

The California Society continues to be on the top of the heap when it comes to processing applications. Both new and supplementals kept me busy in 2013. And 2014 is looking like we could do better in total numbers. Already I see a trend in Junior Member applications.

"How may I help you join the SAR?" I think this should be the question on every CASSAR compatriot's lips. I would venture to say that we remain one of the best kept secret societies in California. I cannot count the number of times I have struck up a genealogy conversation only to find that the person has never heard of the SAR. I would recommend that each compatriot have a handful of business cards in his possession at all times. Who knows? There might be a potential new member in the next new person you talk to. Now here's the tricky part – get the person's telephone number.

Next is the process of getting an application completed. How many of you have Ancestry.com? That program is a perfect site to help gathering data for a new member. Continue your conversation with getting preliminary data – full name, date and place of birth, followed with the name of the parents and

grandparents – whatever you can get. Often this person may not know even his grandparents information. When you get to your computer build a family tree – look for the leaves as they appear – they may be clues to what is needed to trace this person's ancestry back to the American Revolution. Go to dar.org and see if any of their ancestors are listed as an approved patriot by the DAR. You might even discover this through the leaves that appear on ancestry.com. Remember I said get the telephone or cell number. Call the potential new compatriot and share what you have discovered. You might even print up a pedigree chart as a gift.

If you don't have ancestry.com – get it! It is an amazing tool. You can become an expert at filing applications! Now go and have some fun!

Spring Meeting in Sacramento

The Sacramento Chapter hosted the 139th Annual Meeting of the California Society of the Sons of the American Revolution from April 10 - 12, 2014 at the Embassy Suites Riverfront Promenade in Sacramento, California. Seventy-seven SAR members attended, and fourty-four spouses.

CASSAR President J. Stephen Hurst convened the annual business meeting on Friday, April 11. National officers, state officers, committee chairmen, and chapter presidents gave reports. CASSAR Invested Funds Trustee Stephen Renouf presented proposed amendments regarding the various invested funds. The vote was unanimous to approve the amendments on the permanent fund, education fund, congress fund, and the new unallocated fund. The chapter presidents also voted unanimously to change the CASSAR Life

Membership Program to require all new members to obtain a NSSAR Life Membership (which will pay the national dues), and then use the CASSAR Dual Life Member Fee Schedule (which will pay the state and chapter dues). Trustee Renouf announced that he had reviewed the CASSAR Life Membership program and found that the insufficiency of the fund had declined from \$90,991 in 2010 to \$35,053 in 2014. He recommended that we continue to follow through on our action plan to reduce the insufficiency. Once the insufficiency is corrected, the society can address raising the chapter dues paid to chapters (currently fixed at \$10 per life member).

NSSAR Chancellor General John Dodd presented two NSSAR Bylaws Proposals regarding the National Life Membership Program, and regarding the case when a state society loses both their trustee and alternate trustee. The California Society voted unanimously to sponsor the NSSAR Bylaws amendments to the SAR Annual Congress in Greenville, South Carolina, in July 2014. President General Joseph Dooley spoke about his plan to shave his head on the floor of the SAR

Congress if \$1 million in new money was raised for the SAR Center during his presidency. He also announced that the new class of SAR Minutemen included Californian Karl Jacobs.

Don Littlefield of the Sacramento Chapter was the Master of Ceremonies for the Public Service

Luncheon. CASSAR President Steve Hurst and Sacramento President Russ Kaiser presented the awards to the public service recipients. Captain Kevin Snider of the Sacramento Metropolitan Fire District received the SAR Fire Safety Commendation Medal. Deputy Scott McCartney of the Rancho Cordova Police Department and Detective Michael Duggins of the West Sacramento Police Department received SAR Law Enforcement Commendation Medals.

In the afternoon, the CASSAR Ladies Auxiliary took a guided tour of the California State Capitol. The CASSAR Audit Committee met and reviewed the 2013 expenditures and accounting procedures. On Friday evening, there was a dinner at the California Automobile Museum, located less than a mile from the hotel.

On Saturday, the business meeting was re-convened. The Children of the American Revolution(CAR) pages were introduced, and thanked for their service during our meeting. CAR Liaison Jim Young presented a check for \$500 to the Children of the American Revolution to assist in their projects. California CAR Chaplain Leslie Young (daughter of Jim Young) accepted the check on behalf of CAR. CASSAR Chancellor Jeff Goodwin discussed and handed out conflict of interest forms and whistleblower policy forms to be signed by all officers and delegates.

Executive VP Jim Faulkinbury spoke about the upcoming Board of Managers Meeting to be hosted by the Redwood Empire Chapter in Petaluma on November 6-9, 2014 at the Sheraton Hotel. The 2015 CASSAR Spring Meeting was approved to be held at the Wyndham Hotel in Irvine on April 17-18, 2015.

Revolutionary War veteran buried in Sonoma

Compatriots attending the Board of Manager's meeting in Petaluma will have the opportunity to visit the cemetery where the only Revolutionary War veteran buried in California is located. William Smith was born in 1768 in Flowerdew Hundred, VA, on one of the original James River plantations. He joined the Virginia Navy at age 11, serving with his father on the ships Manly, Jefferson, and Tarter. After the war, Smith made 23 round-trip voyages to the West Indies, one voyage to China with 63,000 seal and otter skins, and eight round-the-world trips involved in the California hide and tallow trade. Smith first reached the California coast in 1800, where he made the acquaintance of Captain George Vancouver, who explored the Pacific Coast from Oregon to Alaska. Smith was Captain of the Albatross in 1816 and was nearly arrested for smuggling in Santa Barbara.

William Smith settled in Sonoma in the 1840s after years of sailing the Pacific. He died in Sonoma May 5, 1846, about five weeks before the Bear Flag Revolt, when Sonoma was still part of Mexico. His Revolutionary War service had been recognized by the Sons of the American Revolution. His burial site is believed to be in Mountain Cemetery. Two plaques (one installed by the California Society, SAR in 1994) commemorate Smith's life.

Several years ago, the California Society of SAR discussed the need to recognize participation by Color Guardsmen at the chapter and state level. The Baron von Steuben Medals (BVSM) were created as an award for those Color Guardsmen participating on a regular basis in chapter or state events who otherwise may not qualify for a bronze, silver, or gold NSSAR Color Guard Medal.



A chapter may award a bronze Baron von Steuben Color Guard Medal to a member or non-member for participation in color guard activities at the chapter or state level. Usually, one year of service as a color guardsman or a supporter of a color guard unit will qualify for the bronze BVSM.



The silver Baron von Steuben Color Guard Medal is recommended by the CASSAR Color Guard Commander and presented by the CASSAR President at the Spring Meeting or Fall Board of Managers Meeting. A color guardsman with three years' service may receive the silver Baron von Steuben Color Guard Medal.



The CASSAR Color Guard Commander or CASSAR President determine the awarding of the gold Baron von Steuben Color Guard Medal to no more than three color guardsmen annually. This medal is presented for long and dedicated service to the CASSAR Color Guard. The gold Baron von Steuben Color Guard Medal is presented by the CASSAR President at the Spring Meeting.

Presently, costs for the bronze, silver or gold Baron von Steuben Color Guard Medal are \$20 for the full-size and \$18 for the miniature. The CASSAR Color Guard Commander prepares the certificates. The CASSAR presents only the full-size medal. The miniature may be purchased by the recipient. If a color guardsman has previously received the NSSAR bronze, silver, or gold Color Guard Medal, he automatically qualifies for the CASSAR bronze, silver, or gold Baron von Steuben Color Guard Medal.

The California Compatriot p.21 Operation Ancestor Search in California

Ray Raser is the California Society's Program Chairman for Operation Ancestor Search(OAS). He initiated the program at Balboa Naval Hospital in April. Twenty four volunteers from five San Diego Genealogical Council member organizations gathered at the hospital auditorium with the wounded warriors and hospital staff. Del Ritchhart, Retired Captain in USN Intelligence, presented a 90 minute power point orientation on the Operation Ancestor Search Ancestry.com program.

After lunch, the volunteers were paired with the attending wounded warriors. Ray, Diane Lott (President of the San Diego Genealogy Council), and Capt. Ritchhart assisted the one on one sessions. Ray found it heartwarming to look out over the room and see the excitement of discovery and rapport during the one on one sessions. Arrangements were made for continued interaction based on individual schedules and a group session the next month.

Ray is currently working on developing a plan of action for introducing OAS to Camp Pendleton wounded warriors and staff. He also attended the Southern California Genealogical Jamboree in Burbank, CA where he promoted Operation Ancestor Search to potential volunteers in Los Angeles area.

What is Operation Ancestor Search?

- Operation Ancestor Search (OAS) is a free national genealogy training program for Wounded Warriors, their families, and the medical and installation staff responsible for their care.
- OAS provides participants with the knowledge and tools that allow them to conduct their own genealogy research as they recover from their injuries at military hospitals across the country.
- OAS is a program initiated by the National Society of the Sons of the American Revolution and conducted through its state societies and local affiliate chapters across the country.
- OAS participating chapters are currently fully staffed by volunteers.

Operating Principles:

- OAS is open to all armed services members in a patient status, their accompanying family members and their military caregivers.
- OAS does not charge any participant for the resources or training provided.
- OAS is not a recruiting tool for the SAR; it does not limit participation based on potential eligibility to join our
- The genealogy expertise within the SAR can be used to give back to the U.S. service members who were injured in their service to our nation.
- Many of the wounded soldiers, sailors, airman and marines have a long road to recovery and spend months, if not years, recuperating from their injuries at military hospitals.
- OAS provides these brave men and women a respite from the constant reminders of their injuries.

The California Compatriot p.22 Operation Ancestor Search in California

- OAS provides injured service members with lhe knowledge and tools that allow them to conduct their genealogy research as they recover from their injuries.
- SAR volunteers provide genealogy training classes, work sessions and individual assistance to the OAS participants at the military hospitals.
- OAS offers genealogy resources to the injured service members most notably, free access to Ancestry.com, the program's major national sponsor.

Genealogy Work Sessions:

- Conducted on a regular basis by expert genealogists.
- Basic introduction to genealogy and how to conduct the research.
- Online databases such as Ancestry.com, Fold3.com, Ellisisland.org, Familytree.com, etc.
- National resources such as the DAR and SAR libraries, Library of Congress, National Archives, etc.
- Local and state resources such as libraries, archives, courthouses, historical and genealogical societies.
- Handouts to get started, family tree charts, etc.

Battle Buddies:

- Local SAR member volunteers provide genealogy assistance to soldiers conducting research.
- Individual assistance on case-by-case basis (participants encouraged to do as much as possible.)
- Each participant is eligible.
- Reintegration Program with nationally affi liated NSSAR local chapters in cooperation with members of local and state chapters of the Federation of Genealogical Societies, local libraries, lineage societies, and other groups and individuals who lend their support with training, reintegration and mentoring after the Wounded Warriors transition back to their local communities.

NSSAR Spring Leadership Meeting

The National Society Spring Leadership Meeting was held February 27 to March 1, 2014 in Louisville, Kentucky. The California Society was represented by Jim Faulkinbury, Kent Gregory, Ron Barker, Jim Fosdyck, Bob Ebert, John Dodd, Rev. Lou Carlson, Keith Bigbee, Stephen Renouf, Karl Jacobs, Chuck Lampman, Stan DeLong, and Tom Adams.

Dodd and Carlson attended the **Executive Committee** meeting on Thursday. The Executive Committee appointed Stephen Renouf (CA) and Jim Jones (TX) to make an analysis of the NSSAR Life Membership Fund to determine the fund's adequacy, and develop a new fee schedule based on an actuarial analysis.

Renouf chaired the Medals & Awards Committee meeting, attended by Carlson, Fosdyck, and Jacobs. The committee approved the SAR Ring proposed by the Michigan Society, which includes a donation of \$30 to the SAR Foundation. Approval was given to a medal for the Atlantic Middle States Association, and a fund raising medal for the Americanism Committee's Poster Contest and Brochure Contest. The committee rejected the Genealogist Medal for Supplementals, and returned it to the Washington Society to work on details. Corrections were made to the SAR Handbook regarding the Veterans Recognition Committee and rules regarding the War Service Medal and the Military Service Medal. The requirements for the War Service Medal: the member must show proof on his DD214, or equivalent, showing he received a campaign medal for a war or police action authorized by the US Military. The National Defense Medal would not qualify under these rules. Those serving in the military, but not qualified for the War Service Medal, may receive the Military Service Medal by providing proof of military service on his DD214, or equivalent. The 5-year look back period for the Lydia Darragh Medal and Chapter Medal of Distinguished Service was dropped. The committee approved the SAR Gold Good Citizenship Medal to be presented to President General Joseph Dooley.

Dodd and Renouf attended the **Congress Planning Committee** meeting. Details of the upcoming 2014 SAR
Congress in Greenville, South Carolina were presented.
Other Congresses being planned are Louisville, KY (2015);
Knoxville, TN (2016); Boston, MA (2017); and Houston,
TX (2018). John Dodd presented California's proposal to
host the 2019 SAR Congress in Southern California (Orange
County, Los Angeles or San Diego areas). The committee
voted to approve the proposal and recommend it to the
Trustees.

Dodd attended the **Bylaws & Legal Advisory Committee**, which discussed privacy issues and reform of the record copy request process. DeLong attended the **Knight Essay Committee**, where they recommended an increase in the National prizes to \$3,000 first place, \$2,000 second place, and \$1,000 third place. Carlson and DeLong attended the **Chaplains Committee**, where they discussed the memorial program for the national congress. Karl Jacobs attended the

Ethics Committee meeting, which investigated a charge of misconduct by a compatriot, and recommended action be taken by the president general. Jacobs attended the Historic Sites and Celebrations Committee meeting, which discussed upcoming events prior to the Annual Congress. He attended the Library and Archives Committee meeting, where they discussed library activities and materials in the archives, and the Merchandise Committee, where the staff discussed the merchandise being carried and the volume of anticipated business once the Main Street facility is open to the public.

DeLong and Lampman attended the **Minuteman**Committee, where the class of 2014 was selected. DeLong attended the **Veterans Committee**, where they selected honorees for the national congress. Fosdyck and DeLong attended the **Color Guard Committee**, where Sam Powell was selected as NSSAR Color Guardsman of the Year. DeLong also attended the **History Committee**, where they discussed what a military encampment would look like during the Revolutionary War. Renouf attended the **Strategic Planning Committee** which voted to finish the final items for the long range strategic plan.

DeLong, Barker, and Adams attended the Americanism Committee, which approved the Americanism Youth Contest Medal to raise funds for the Poster and Brochure contests. Tom Adams reported on the Middle School Brochure Contest, and made an appeal for volunteers to be judges. He suggested a sub-committee be formed to investigate placing the poster and brochure contests on the National Advisory List of Student Contests and Activities. A proposal was made to amend the Americanism theme currently chosen for the next three school years to be compatible with the curriculum being taught in schools.

The **Patriotic Outreach Committee** was attended by Barker. Seventeen State Societies and 94 chapters have submitted forms to receive the Partners in Patriotism Certificate at the 2014 National Congress. Wreaths Across America keeps growing with 565,000 wreaths being laid at 908 locations. The USO PG initiative of donating \$250 has raised over \$6,000.

Faulkinbury and Adams attended the **CAR Liaison Committee.** CASSAR donated \$100 for the CAR Flag Pole project. Adams recommended that National CAR should revise future CAR Program Packets to encourage participation by CAR members in SAR contests. Barker and Adams attended the **Education Committee.** The California, Florida, and Texas Societies have endorsed Values Through History's Why America is Free curriculum, and the National Society is considering an endorsement. The committee discussed the One Page Education Outreach profiles to be placed on the sar.org website. Successful programs were discussed, including the "Traveling Trunk" program in Georgia, Colorado's "Patriots Chest," and the use of airport display cases.

NSSAR Spring Leadership Meeting (continued)

Faulkinbury, Gregory, and Fosdyck attended the Genealogy Committee meeting. A sub-committee on the policy of grandfathering SAR and DAR applications was unable to come up with a recommendation, so no action was taken. There was a discussion about risk management and redaction of certain items required on SAR applications. Action was taken to recommend that there be a "Do Not Duplicate" option for future members to not allow their applications to be copied. A sub-committee was appointed to examine the issue of allowing DAR "Chapter Copies" as a substitute for official "Record Copies." There was consensus that place names for states and counties on applications should be listed as they existed at the time of the event. There was a discussion about how the name of the patriot should be listed on the application. The name should be spelled as it is found in the record that established service and if more than one spelling is found they could be all included separated by slashes. The applicant can request a preferred spelling on his membership certificate in a letter stating the preferred spelling. There was a discussion about the "Look Up" service by the Genealogy Staff to see if an old SAR application is acceptable documentation for a new application. It was decided that State Points of Contact can continue to contact Susan Acree for inquiries.

The **Museum Board** meeting was attended by Board member Gregory. Prior to the meeting, the members had evaluated 1,999 items that belong to the National Society to determine what items to keep when the staff moves into the new location on Main Street. One hundred-sixty-seven artifacts were determined to fit the Museum's collection criteria for exhibits. Another 942 items were designated for transfer to the SAR Library's Special Collection. The SAR Education Department received 129 items for use with children. Seventy-four items, mostly furniture, were transferred to the Executive Director for use in the offices. De-accession was recommended for the remaining 687 items. They are to be sold if of value, or disposed.

The **Trustees** of the National Society, composed of the past Presidents General, the national officers, and representatives of the state and foreign societies, met Saturday morning. A resolution was approved for PG Dooley, Secretary General Brock, and Treasurer General Lawrence authorizing them to deal with PNC Bank regarding a bequest left to the SAR. Another resolution authorized Dooley, Brock, Lawrence and Don Shaw to enter into agreements with 5/3 Bank to reduce the fees charged to the SAR. A motion was approved to bring the management of special purpose funds into compliance with UPMIFA and other laws. The Executive Committee appointed Stephen Renouf and Jim Jones to analyze the adequacy of the National life membership program, update the fee schedule, and recommend guidelines to states that have life membership programs. Chancellor General Dodd reported that more attention was needed for "risk management." The national office will be creating procedures to protect private information held by the SAR – including some information on SAR application

copies. Dodd suggested that societies investigate the laws of their particular states to protect themselves. PG Dooley reported that there was an offer of \$750,000 made for the old headquarters building on Fourth Street. The SAR had it on the market for \$1.4 million based upon a 2007 appraisal. The opinion of the trustees was that this offer should be rejected and not be countered. The SAR will get a new appraisal of the property.

The Congress Planning Committee reported on upcoming SAR Congresses to the **Trustees**, who will vote in the fall on the selection of California for the 2019 SAR Congress. The Government Relations Committee made a resolution that chapters and state societies contact local governments to recognize the 125th anniversary of the Sons of the American Revolution, and this passed unanimously. The Minuteman Committee announced the class of 2014, which included Karl Jacobs from California. The Museum Board requested action regarding the assignment of 1,999 SAR assets to the Museum, Library, Executive Director, or Education Director. All excess items will be de-accessed to sell or destroy them. The motion was approved.

The Nominating Committee made recommendations for the national society elections in July: President General Lindsey Brock (FL), Secretary General Tom Lawrence (TX), Treasurer General – Mike Tomme (GA) and Larry Cornwell (AL) equally qualified, Chancellor General John Dodd (CA), Registrar General Larry Guzy (AL), Historian General Bobby Towns (GA), Librarian General Bruce Pickette (AL), Chaplain General Randy Moody (FL), Surgeon General Ed Rigel (GA), and SAR Foundation Joe Dooley (VA). The Strategic Planning Committee presented six core competencies – people, historical, patriotic, educational, internal, and external – as well as the objectives, action plan, budgeting, and metrics for each. The Trustees approved the strategic plan unanimously. A motion was approved to use a credit line to help pay for the move from the old building to the new headquarters on Main Street.
