This aerial view of the Mission Inn shows the entire complex which, by itself is worth a visit. It rivals many European historic sites. From its modest beginnings as a 12-room adobe boarding house to its current stature consisting of 239 guest rooms, the *Mission Inn Hotel* has been a major tourist attraction in Southern California since 1876. In the late 1800's wealthy easterners and Europeans flocked to Riverside in search of a warmer winter climate along with the desire to invest



in the area's profitable citrus industry. In 1903 the 'Mission' wing was built in Mission-Revival style architecture and sought to incorporate different structural elements of the 21 California Missions. Over the years the hotel has played host to numerous celebrities and dignitaries. Ten U.S. Presidents stayed at the Mission Inn.

Perhaps it is because our exposure to the communities had dwindled a bit. Perhaps our fellow members are not reaching out as they could to their family, friends and neighbors. As you may be aware SAR has instituted a revision in the policy for post-1985 DAR records. I hope that you are seeking these records as you compile the applications. New also are some of the DAR records we can download that contain the supporting documents, for a fee of course. But something is better than nothing. I have had the opportunity to do exactly that and in two of the three occasions obtained documents that were very helpful.

Now the hard ball. Compatriots, there are no short cuts to a quality "approval ready" application. I continue to get ancestry. com pages that are not usable. I continue to get unreadable pages downloaded from who knows where. Census MUST be complete pages, paying attention to whether they are landscape or portrait. Of course it is OK to add a readable detail enlargement on the reverse. The ancestry.com abstract page for a census is not an acceptable proof. It is not permissible to cut and paste sections of a document and use it as a proof. Complete pages are only accepted. When in doubt read the manual or call me and we can reason it out. I will even forward a questionable document to National and get their opinion before we submit an application only to get it "pended."

Speaking of Pended Applications. Many of you have been assisting the State Genealogist and myself in resolving past pended applications. We have conquered quite a few and have approvals on them but there remains more to complete. Please give your attention to the pended applications for your chapter. At last count there were 32 new members languishing in this "pended" limbo.

Our collective goal this year is to resolve all of the pended applications as far back as 2012 and have zero, none, nada pended applications for the remainder of this year. 2015 will go down in our registrar history as our best year for submitting "approval ready" applications.

## CREATOR OF SAR'S BROCHURE CONTEST IS NOW A SAR MEMBER

Kevin Tierney, a teacher, just became a member of SAR and the Mother Lode Chapter, but his story and his connection to SAR go back some time. In 2009 Tom Adams was appointed the State's Youth Activities Director. In his appointment letter, then CASSAR President Lou Carlson charged Tom with coming up with a "Middle School" program. There was not a middle school program in the State or in all of NSSAR. Tom found the emails of local middle school teachers on-line and sent them all an email with a plea for help. Kevin, an 8th grade teacher in El Dorado Hills at the time, answered Tom's call and offered to help, which triggered a series of 'after Kevin had several ideas for school' meetings. contests from his teaching experience. One program, a brochure contest looked very promising. It had three qualities: (1) any student could do it - no technology required; (2) creating a brochure is a wellknown skill – students can do this; and (3) it is the perfect bridge between the hand-drawn 5th grade

poster contest and the high school written Knight Essay contest. Kevin prepared an 8-page guideline containing the rules for developing the brochure and then for judging it. CASSAR accepted the proposal based upon Kevin's guidelines, and Wayne Griswold, VP North at the time, took the same proposal to Mike Tomme, then Chairman of the NSSAR Americanism Committee. The National Society, which was also looking for a national "Middle School" program, adopted the Brochure Contest with the understanding California would develop a program based upon the proposal – that was in 2009. As we now know the Brochure Contest is in its second year as a National contest.

But Kevin wasn't done. He 2011 he applied for and won the CASSAR Valley Forge Teacher Scholarship to attend the Valley Forge Freedom Foundation Graduate Teacher Program. Upon his return he was invited to be the guest speaker at the CASSAR BOM Meeting in San Diego in November 2011. Kevin's presentation, on the importance of what our SAR society is doing in education so impressed the attendees that State and National Officers urged Mother Lode members, Wayne Griswold, Jim Young and Tom Chilton to work on Kevin's genealogy to bring him into the society. We need members like Kevin, they said. In early 2015 Tom Chilton solved the problem and Kevin's Pennsylvania Militia Patriot was fully documented. ... Welcome Kevin!

The NSSAR Spring Leadership Meeting was held at the Brown Hotel in Louisville, Kentucky on March 5-7, 2015. The California Society was represented by President Jim Faulkinbury, NSSAR Vice President General - Western District Stephen and Joy Renouf, NSSAR Chancellor General John Dodd, Executive Vice President Kent Gregory, Vice President North Ron Barker, Vice President South Jim and Un Hui Fosdyck, Past President Charles Lampman, Past President Karl Jacobs, Tom Adams, Derek and Janet Brown, Gary Jensen and Ray Raser.

On Thursday, members of President General Lindsey Brock's Executive Committee (including VPG Renouf, and Chancellor General Dodd) were shuttled to the SAR Headquarters building for an ExCom meeting. The committee reviewed the income statements and balance sheets, and discussed the 2016 budget. Mike Elston discussed a possible project with King's College London. They have the King George III personal papers, which have not been studied. They plan to digitize the papers and make them available for researchers, and want to partner with universities and groups such as the SAR. We will explore the possibility of partnering with them – possibly endowing an American researcher to study the papers, and perhaps using them at a future SAR Conference on the American Revolution. PG Nathan White reported on the construction activities at the headquarters building.

In the afternoon, VPG Renouf attended the Strategic Planning Committee meeting. Three students in the University of Louisville's MBA program attended the meeting to discuss their degree project to create a business plan for SAR. They only have a couple of months to work on the plan, so they are limiting it to a business plan for the SAR Museum and Educational Outreach Center. At a later date, we can have another group of graduate students work on a business plan for the SAR proper. The students are gathering data from Executive Director Don Shaw and the SAR staff, as well as making contact with the other museums on Main Street. They will meet with their professors to work on various aspects of the business plan, including raising revenues, marketing, web site development, and setting a target audience for the museum. The plan should be presented to ExCom prior to the SAR Annual Congress in June, so it can be presented to the delegates at Congress. Each one of the students has their own business that they developed through the MBA in entrepreneurship program at the university, and brings their own special talent to the project. The students then asked questions of the committee to get a better idea of what the SAR is, and what we are trying to accomplish. Following the presentation, the Strategic Planning Committee voted to recommend to the trustees the long range plan that has been developed over the last couple years.

On Friday, the national committees met at the Brown Hotel. In the morning, VPG Renouf chaired the Medals & Awards Committee, attended by VP South Fosdyck. The two Leadership Meetings and Congress are also now considered as official meetings of the Council. The committee voted unanimously to change the rules for the Silver Council of State Presidents Medal to require attending 4 meetings of the council (an increase from the present 2 meetings). The committee voted unanimously to modify the rules for the Bronze Good Citizenship Medal with regards to Navy Sea Cadet Corps. The medal would NOT be authorized for the Navy League Cadet Corp (cadets aged 9-13). A Navy Sea Cadet would need to be in the next to last year or last year in the program, and have attained the rank of petty officer second class or higher. The committee voted unanimously to create the Hospitality Award for the PG to present to ladies who assist him during his term (similar to aide de camp pin), the 2016 Congress Medal proposed by the Massachusetts Society, the Kentucky Society's Isaac Shelby Centurion Award to recognize the service of SAR Members to the Kentucky Society, the Southern District SAR Membership Medal available to all members of the AL, LA, MS, and TN state societies, and the Washington Society's Superior Service Medal to recognize continuous exceptional service of SAR Members to the Washington Society. The committee voted that the National Defense Service Medal was not considered a campaign medal for purposes of qualifying for the War Service Medal. The committee went into executive session to discuss proposals for the SAR Gold Good Citizenship Medal, and voted unanimously to approve awarding the medal to General Michael V. Hayden (proposed by the DC Society), and President General Lindsey C. Brock (proposed by the Executive Committee).

VPG Renouf, Chancellor General Dodd, President Faulkinbury, and Executive VP Gregory attended the Congress Planning Committee. CASSAR Congress Planning Chairman Dodd spoke on the hotels that are going to be reviewed by Paul Callanan in a couple weeks in Orange County and San Diego as possible sites for the 2019 Congress in California. Other chairmen spoke about the 2015 Congress in Louisville (KY), the 2016 Congress in Boston (MA), the 2017 Congress in Knoxville (TN), and the 2018 Congress in Houston (TX). For the upcoming Louisville Congress, there will be an outing to Churchill Downs on the Friday preceding Congress. The Saturday tour will feature George Rogers Clark, and the Wednesday tour will be to the Kentucky horse park.

President Faulkinbury chaired the Genealogy Committee, with Kent Gregory, Gary Jensen and Ray Raser present. The committee approved a revision of Policy 2011-06 to accept DAR or CAR Record Copies approved on or after January 1, 1985, as evidence of corresponding lineage and related facts on SAR applications. Earlier DAR or CAR record copies will be accepted as evidence only for corresponding facts that have verification marks. Now that this has been done, they may have to revisit the SAR grandfather clause and adopt a similar policy. The policy does not apply to portions of DAR or CAR applications that have been determined as incorrect by DAR, CAR, or the SAR Genealogist General. The Committee also voted to revise Policy 2005-03 to no longer require a long-form birth certificate for the applicant. Executive VP Gregory attended the Council of State Presidents, which shared information on which states have found black powder liability insurance.

The Premium Membership Medals Committee met with Chairman Renouf, John Dodd and Karl Jacobs. The meeting ended early so we could watch Un Hui Fosdyck perform several Korean dances for the Ladies Auxiliary Meeting. The Spanish Patriots Committee met, led by Vice Chairman Renouf. Chairman Renouf discussed two Spanish descent applicants from Miami, Florida, that he successfully sponsored for membership in the Thomas Jefferson Chapter in California. Both descend from a soldier in the Spanish Havana Regiment that served with General Bernardo Gálvez. Chairman Renouf also discussed two applications that he is working on for the Spain Society. Both men are American businessmen living in Madrid. The completed applications have been sent to them for signature. The applications are strong, and we should have two new members for the Spain society in a month or two. The Spain Society is making a trip to Cartagena, Spain, with the DAR and Spanish military in the next few months.

President Faulkinbury attended the Patriot Biographies Committee. The States and Chapters with 20% participation by June 1, 2015, will receive a streamer. The 20% calculation will be the number of bios submitted by the State Societies or individual chapters divided by the number of members in that State or Chapter on January 1, 2015.

President Jim Faulkinbury attended the IT Committee, which provided a presentation on the new software functionality for online applications and several of the business functions being developed. Jim has been participating as one of the beta testers of the online application system prior to this meeting and will continue with that when the next release is ready for testing.

John Dodd attended the SolidLight Ad Hoc Committee, where they viewed an informative power point presentation of the Museum of Alabama, which is similar in size and scope to what is being proposed for our building, demonstrating we are consistent in cost with other similar projects. Kent Gregory and John Dodd attended the Museum Board Committee. The Museum Board voted to transfer a Dry Mounting Press to the Education Director, and approved the sale of a drill press. A subcommittee was formed to provide recommendations to the next President General for appointments onto the Museum Board. A subcommittee was formed for long range planning for commemorative themes for temporary exhibits. The Committee approved a policy for historical accuracy regarding NSSAR artifacts.

CASSAR Color Guard Commander Jim Fosdyck attended the Color Guard Committee. The committee selected Robert

Cunningham of Indiana as Color Guardsman of the Year for 2015-2016. They also passed a resolution stating that compatriots wearing a kilt may not March with the color guard at National events. VP South Fosdyck attended the Public Service/Heroism Committee, where they discussed guidelines for awarding Law Enforcement, Fire & EMS medals, and reporting awards information to National. He also attended the ROTC/JROTC/Academies Committee.

Chuck Lampman attended the Minuteman Committee and helped choose the six members of the class of 2015 - Davis Wright, Esq. (DE), Mark Anthony (SC), Randy Moody (FL), Joe Harris (UT), Peter Grassl (KS), and Dr. Raymond Clapsadle (TN).

VP North Ron Barker attended the Education Committee. So far, nine states, including California, have submitted a one-page document on education outreach. On its website, Georgia has a traveling trunk which chapters can use in putting together an education outreach program. The "Why America is Free Curriculum" was endorsed by the 124th Congress in Greenville, SC. The committee is asking for further best practices of chapters or state societies to share with other societies.

VP North Barker attended the Americanism Committee meeting where it was announced that 28 percent of all chapters participated in the Americanism Contest for 2014. There were many outstanding programs listed on the worksheet that will be shared when it is all compiled. In addition, the Elementary School Poster Contest will now alternate yearly between the Founding Patriots and Events of the Revolution as on-going themes.

VP North Barker chaired the Patriotic Outreach Program where it was announced that there was the largest participation ever of Chapters and State Societies in the Partners in Patriotism and Wreaths Across America programs.

The Friday night banquet was held at the Brown Hotel. One of the MBA students addressed the assembly about the project to develop a business plan for the SAR Museum and an Educational Outreach Center. The Minuteman Class of 2015 was announced at the banquet.

On Saturday morning, the Executive Committee was shuttled to the SAR Headquarters building. Member Stephen Renouf presented the recommendations of the Medals & Awards Committee, and they were approved unanimously. The committee voted to recommend the long range plan of the Strategic Planning Committee to the trustees. The committee discussed the various parts of Phase III, and decided to prioritize three items - an electrical upgrade (since the power to the building is currently maxed out), installing the rear elevator, and finishing the rooftop garden.

The trustees and members of the SAR were shuttled to the SAR Headquarters building for the Trustees Meeting. The main topic of the trustees meeting was the SAR Museum and Educational Outreach Center, so it was decided to hold the meeting in the partially finished area where the museum would be located. The trustees were able to see the building and visualize the space. A panel discussion was held with Dan Preston from Architection, Leo Post from AL Post Construction, John Murphy from SolidLight (the company that will plan and execute the SAR Museum), Chairman Bill Stone of the Ad Hoc Committee, and President Sam Powell of the SAR Foundation. Each representative gave a presentation on his part of the project, and then opened the floor to questions from the trustees. It was a great opportunity to clear up any misconceptions about the project.

Following a working lunch, the trustee meeting reconvened. The trustees voted to approve the recommendation of ExCom for the three next projects in Phase III - electrical upgrade, rear elevator, and rooftop garden. There was a discussion about why the rooftop garden was being prioritized - once finished, it can be rented out to generate additional income to finish the Museum and Outreach Center. Each year, the Thunder over Louisville fireworks are exhibited. Many companies pay \$25,000 for the single day to rent rooftops on Main Street to view the fireworks, often with multi-

We already have one wedding scheduled for the unfinished first floor area. This will be a great opportunity to help raise revenues for the project and for eventually funding the museum. The trustees voted to approve the deaccession plan for unneeded microfilm and microfiche. The trustees approved purchasing computers for the SAR Library, as well as approved using the Millett Fund to pay for Library renovation. The investment asset allocation for the Alexander Hamilton Fund and George Washington Endowment Fund was approved. The Strategic Planning Committee recommended adopting the long-range plan, and it passed. Bill Marrs discussed transitioning from Dropbox to Share File for keeping trustees and committees informed of important items.

Following the trustees meeting, VPG Renouf attended the meeting of the Council of Vice Presidents General. They approved a bylaws modification regarding the appointment of the Council Chairman to bring their bylaws into agreement with the NSSAR bylaws.

In the afternoon, John Dodd, Karl Jacobs and Stephen Renouf attended the meeting of the SAR Germany Society. President Bruce Buehler spoke about several new members for the Germany Society resident in Germany. New officers were elected for 2015. Germany Society pins were being sold to raise funds to purchase two silk Zweibrüken Regiment flags for the society.

John Dodd attended the SAR France Society meeting, where they discussed the recent, very successful SAR trip to France, as well as the possibility for future trips. The France Society is involved in the voyage of the ship Hermione and various other commemorations of France's contribution to our revolution, and welcomes visits from SAR members for any of these events. They also discussed the youth exchange program and the possibility of other avenues for cultural exchange.

Jim Fosdyck chaired the meeting of the Mexico Society in the absence of President Carlson. They discussed the Mexico Society Fiesta at the 2015 SAR Congress.

The Saturday night banquet was held at the Brown Hotel. The honored guest was President General Roland Downing, who served in 2005-06. Roland spoke about the origin of the idea for the SAR Outreach Education Center. He noted that in the 1980's, school textbooks were revised to include the history of minorities in the US, and unfortunately, that meant cutting important people and events from US history. The information that has been removed has had a negative effect on American culture by making students illiterate in their own culture. The idea of the SAR providing educational outreach to fill in their vital gap in students' education eventually led to the idea of the SAR Outreach Education Center. Information on the fight for freedom from Great Britain, and the establishment of the Republic of the United States can be developed and disseminated to teachers and schools. The United States motto - E Pluribus Unum (Out of many, One), was the driving force of the United States from the founding. People could come from anywhere in the world, and assimilate into our society and culture. Unfortunately, the forces of multiculturalism have divided and fragmented our county, and we need to reestablish E Pluribus Unum as a guiding force. President General Downing also discussed how he became interested in genealogy, and how it led him to discover the history of his family, and how it was interwoven in the history of the a United States. That led to him joining the SAR 35 years ago, and the rest is history. CASSAR Color Guard Commander Jim Fosdyck, Kent Gregory, Gary Jensen and Stephen Renouf participated in the National Color Guard for retiring the colors.
