Note #1: When using a lineage which has already been accepted by the SAR or DAR a record copy of the referenced SAR or DAR application must be provided with the documentation and all dues and fees shown above. **Note #2:** Establishing a new lineage or patriot ancestor – if you are applying as a junior member and the ancestor you are applying under has not been documented or approved through the SAR, DAR or CAR in the past the application cost is shown above.

Note #3: Applications of family members must be submitted at the same time, follow the same lineage to the same patriot ancestor and be within two generations of one another (grandfather to grandson, uncle to nephew, etc.).

Note #4: The applicant must provide his birth certificate, a copy of his C.A.R. Member of Good Standing card and a "record copy" of his C.A.R. approved membership application form.

Note #5: The Memorial Dues/Fees have been changed to reflect the same amount as "Regular" Dues & Fee.

Secretary's Report

January proves to be a challenging month with the chapter's reconciliation reports due on or before January 5, 2020 and then the payment of dues to CASSAR with one check by January 15, 2020.

The change of officer forms need to be submitted by January 15, 2020 as well. These forms are needed because they begin a flurry of CASSAR reports that must be completed by months end.

After all of the January reports are complete, then comes the "Oh-My, I forgot to renew and send in my dues" and we have a surge of members that want to reinstate their membership. Members wishing to reinstate after January 1, 2020, paperwork will be submitted to NSSAR however, their profiles most likely will not be updated until after April 1, 2020 because of Reconciliation Reports being processed Nationally.

March first (March 1, 2020) will be just around the corner and each chapter needs to submit a two page annual report to, guess who, the CASSAR Secretary, no later than March 1, 2020 so it can be included into "The Book" that is published for the Spring Annual Meeting of the Membership. The format this year will be a bit different than years past and I will be asking each chapter to submit a similar format to help keep printing and publishing cost to a minimum, more on this to follow.

The coming year looks to be an exciting year for all of us and I look forward to working with all of the membership, please if you have any question pick up the phone and call, I will do my very best to help get the answer.

Arthur M. & Berdena King Eagle Scout Award – 2019 Temporary Transition Rules Extension

As of February 1, 2019 Boy Scouts of America has revised their membership rules to allow females to become scouts. With the inclusion of female scouts they have revised their primary name to "Scouts BSA". This revision will allow females to advance to the Eagle Scout Rank. To provide a transition period for those that joined on February 1st to be able to achieve the rank of Eagle Scout, Scouts BSA has made a "Temporary Transition Rules Extension". The NASSAR Eagle Scout Committee has adopted this extension and it can be found on the NASSAR web site at this link:

Here is the key wording of the extension"

"Temporary Transition Rules Extension — Any youth who registered as a member of Scouts BSA between February 1, 2019, and December 1, 2019 and was granted an extension by the National Council BSA to complete the Eagle Scout rank requirements after they have turned 18 years of age, will have 365 days from the date their Eagle Scout application was validated by the National Advancement Program Team to enter the contest."

A copy of the approved extension must be attached to the contest application.

This should clarify for your Chapter competition that in the future you will possibly have both male and female applicants. If you have any questions please contact Bill Nay, Chair of the California Society Eagle Scout Committee.

Cyber Scams Alert

Be aware, be alert, be vigilant!

"I need you to process a payment today..."

"Do you have a few minutes to mail a check today..."

"I need you to get a couple of gift cards for me today..."

"Are you available to complete a bank transfer today..."

"I need you to make a payment of \$4,859 today..."

"Can you process a transfer of \$8,850 today..."

If you receive an email addressing you by name from another officer or individual in your chapter, you may be the target of a cybercrime. Chapter Treasurers and those with access to your Chapter accounts, may receive emails

requesting the expenditure of chapter funds.

Beware! Always be on the lookout for scams, especially those requesting disbursement of Chapter funds.


Don't be naïve. Use your head. Validate all such requests before taking the requested action.

Do not reply to the email you received or call the number provided in the email.

Instead, call your President, VP, Secretary or Registrar directly or send them an email using their known telephone number or email address. Ask them directly if they made the request.

Implement a two-party authorization process in place for payment. CASSAR uses a check request form downloadable from the CASSAR website. Chapters may not need a form, although from a legal and record perspective it's not a bad idea.

Have a process and procedures in place with a clear understanding by all officers to make sure Chapter expenditures are legitimate.


Silicon Valley Chapter News





The 144th CASSAR Board of Managers Meeting

The 144th CASSAR Board of Managers Meeting was hosted by the Orange County Chapter at the Wyndham/ Sonesta Hotel in Irvine, California, on October 31 to November 2, 2019. On Thursday, October 31, 2019, the State Officers hosted President General Jack Manning and First Lady Sheila Manning for dinner at Muldoon's Irish Pub in Newport Beach, California. Other national officers in attendance included Genealogist General Jim and Karen Faulkinbury, Vice President General James and Un Hui Fosdyck, SAR Foundation Board Member John and Karen Dodd, SAR Foundation Board Member Rev. Lou and Karen Carlson, NSSAR Trustee for California Derek and Janet Brown, NSSAR Trustee for Spain Stephen and Joy Renouf, and NSSAR Trustee for Nevada Charles Smith.

On Friday morning, November 1, 2019, President Robert Taylor convened the CASSAR Board of Managers Meeting. Following opening ceremonies, the National Officers were introduced – President General Jack Manning (NH), Genealogist General Jim Faulkinbury (CA), Vice President General James Fosdyck (CA), and SAR Foundation Board Members John Dodd (CA) and Rev. Lou Carlson (CA). The past state presidents were then introduced – Robert Ebert (2006-07), Karl Jacobs (2007-08), Stephen Renouf (2008-09), Rev. Lou Carlson (2009-10), John Dodd (2011-12), Jim Faulkinbury (2014-15), Kent Gregory (2015-16), Ronald Barker (2016-17), Jim Fosdyck (2017-18), and Derek Brown (2018-19).

The National officers gave their reports. PG Jack Manning noted that the Sons of the American Revolution currently has 37,451 members. He has visited the hotel for the 2020 SAR Annual Congress in Richmond, Virginia, and encouraged all members to attend. Genealogist General Jim Faulkinbury said the membership is down over 400 members this year. He said about 15% of applications submitted are pended, and he reminded compatriots that the Patriot Research System cannot be used as proof of service, nor can the unverified Patriot Biographies on the SAR Website. NSSAR Trustee for California Derek Brown reported that Jim Klingler, Stephen Renouf, and he performed an audit of the California Children of the American Revolution books at their request. SAR Foundation Board Member John Dodd noted the SAR Foundation has two capital campaigns at present – the Liberty Tree Campaign and the 1776 Campaign. Members may give a monthly donation, or a one-time donation. The building has been completed, and now we are ready to start building the SAR Museum. When we ask corporations to donate money, they want to know that at least 25% of the members have contributed, so it is important for members to donate. John Dodd encouraged attendees to inform their chapters about the SAR Museum, and encourage donations.

The California Society officers gave their reports. Executive Vice President Don Littlefield reported that the Valley Forge Freedom's Foundation event in Rocklin, California, had 1,800 children visit it over two days, and they had exhibits on the American Revolution. Vice President North Craig Anderson reported that he was working with the Redding Chapter to spin off their members to other chapters. They voted to return their charter, and they turned over the chapter funds to the California Society, which will hold it in trust for 2 years in case the chapter is reactivated. Vice President Membership Doug Bergtholdt handles new member referrals, so he needs to be informed when chapters change registrars. Secretary Fred Schuster reported that he was organizing the state files, and he sent out the annual reconciliation forms to chapters, which he needs submitted to him by January 5. He needs chapters to fill out the change of officers form, and submit it to him after the 2020 elections. Treasurer Jim Klingler reported that the congress expense of \$54k has distorted this year's activity. Some of the revenue was raised in previous years, and the \$18k had not been transferred from the Congress Fund as of September 30. He said the tax forms have been filed for this year, and that the California Society is a test site for the 2021 National Society dues collection program. Registrar Owen Stiles reported that we have processed 15 junior member applications, 2 memorial applications, 127 regular membership applications, and 113 supplemental applications so far this year. We have 119 applications at National, with 18 of those pended. He urged chapters not to use undocumented family histories, and old DAR applications as proof on applications. Chaplain Lou Carlson asked chapters to notify him of deceased members, and also provide him the contact for the next of kin so he may contact them.

The Nominating Committee – composed of past presidents Lou Carlson, John Dodd, Jim Faulkinbury, Kent Gregory, Ron Barker, James Fosdyck (Chairman), and Derek Brown – retired to evaluate new candidates for office in 2020. The chapters gave their reports. When the Nominating Committee returned, Chairman James Fosdyck reported on the nominations for California Society office in 2020: Executive Vice President Brian Stephens, Vice President North Craig Anderson, Vice President South James Klingler, Vice President Membership Doug Bergtholdt, Secretary Fred Schuster, Treasurer John Ferris, Registrar Owen Stiles, Chancellor John Dodd, Esq., Genealogist Terry Briggs, Historian James Blauer, Chaplain Rev. Lou Carlson, Surgeon Dr. Matthew Bowdish, and Invested Funds Trustee (3-Year Term) Stephen Renouf. Those not standing for election are President Don Littlefield, Immediate Past President Robert Taylor, Invested Funds Trustee (2019-2021) Kent Gregory, and Invested Funds Trustee (2018-2020) John Dodd, Esq. Recommended for NSSAR Trustee for California was Robert Taylor, with Don Littlefield as Alternate Trustee. The elections will be held at the April Meeting in Rancho Murrieta, California. The Board of Managers confirmed the appointments of Fred Schuster as current secretary, and of Jim Blauer as current historian. The meeting was adjourned for lunch. The Ladies Auxiliary held their board meeting in the San Clemente Room on Friday morning.

The Public Service Luncheon was chaired by Brian Stephens of the Riverside Chapter. President Mark Torres of the Orange County Chapter brought greeting, as did CASSAR President Robert Taylor. President Taylor awarded the SAR Fire Safety Commendation Medal to Lori Zeller, the deputy chief of the Orange County Fire Authority. He presented the SAR Law Enforcement Commendation Medal to Lieutenant Matt Mahoney of the UC Irvine Police Department. Following Friday lunch, the Ladies Auxiliary had a behind the scenes tour of South Coast Plaza – the largest shopping center on the West Coast.

The Board of Managers Meeting was reconvened by President Taylor. Chapter reports continued, followed by the Youth Activities Reports. Poster Contest Chairman Dave Gilliard reported that he had a Youth Contest file in Word, and he will send it to anyone who requests it. Eagle Scout Chairman Bill Nay reported that the chapter winner gets a patch, and the new version of the patch is being sold on the SAR website. There is only one nominee for the SAR Robert Burt Scout Award, so if there are any other candidates, please inform Chairman Nay as soon as possible.

The CASSAR Committee chairmen gave their reports. John Dodd reported that all California Society members who have donated \$250 to the SAR Museum Project are eligible to wear the California 250 Pin – including everyone who donated \$250 for the SAR Premium Membership Medal. Compatriots were reminded that all chapters should be awarding SAR Flag Certificates to persons and organization that fly the US Flag in a proper manner.

The State will receive the Admiral Furlong Award if the state society and ½ of the state chapters present an SAR Flag Certificate in a year. There is also the new SAR Flag Retirement Certificate awarded to groups that properly retire unserviceable US Flags. Many groups such as Disabled American Veterans, ROTC, American Legion, Boy Scouts of America, etc. that have programs to properly retire flags. Compatriots may attend the ceremonies, and present the certificate to them.

Brian Stephens reminded chapters to report to him when they present Public Service Medals (Law Enforcement, Fire, EMS, Heroism, and Life Saving Medals) so he can be sure they are reported to the National Society for inclusion in the Public Service Program at the next SAR Congress. Chairman Don Littlefield announced that the Wreaths Across America ceremony would be held on Saturday, December 14, 2019, at 9AM in California. He encouraged compatriots to attend ceremonies at cemeteries in their area, and report their participation to him so CASSAR will get credit for supporting the program. President Taylor then adjourned the meeting until the following day.

On Friday evening, the CASSAR President's Dinner was held at El Torito Grill in Irvine, California. We walked over to the restaurant from the hotel, and had a Mexican buffet for dinner.

On Saturday morning, November 2, 2019, the past presidents met for breakfast: Robert Ebert, Karl Jacobs,

Stephen Renouf, Rev. Lou Carlson, John Dodd, Jim Faulkinbury, Kent Gregory, Ron Barker, Jim Fosdyck, and Derek Brown. President General Jack manning was a guest. The past presidents discussed issues regarding the state society. Janet Brown convened a general meeting of the Ladies Auxiliary on Saturday morning in the San Clement Room.

The California Society meeting resumed in the morning. The Budget/Audit Committee retired to review the financial reports of the society for the current year. Executive Vice President Don Littlefield chaired the meeting, and the committee was composed of Jim Klingler (Treasurer), Stephen Renouf (Trustee of the Invested Funds), Brian Stephens, Craig Anderson, John Ferris, Bill Nay and Kevin Bidenkap. Don Littlefield presented his proposed budget for 2020, and the members of the committee recommended a few changes – adding items for CASSAR online file storage, and for communications software. Then, an audit of the books for January through September 2019 was conducted, and all deposits and checks audited were produced. Treasurer Klingler was commended for the work he is doing as treasurer.

Chairman Don Littlefield presented the proposed 2020 budget for the committee, and the Board of Managers approved it. Treasurer Jim Klingler said CASSAR has identified a non-profit insurance company that will sell liability insurance and director/officer insurance to CASSAR chapters for \$625 per year. Any chapters wanting information may contact him.

Invested Funds Trustees Stephen Renouf (chairman), John Dodd, and Kent Gregory presented the Report of the Invested Funds Trustees. Over the previous 12 months, the total amount of the invested funds decreased by \$7,920.43. The decrease was primarily caused by using the 2019 Congress Fund for our obligations as the host society. After the final reconciliation, we have a \$13k balance left in the Congress Fund for future congresses hosted by the California Society. We will be changing the risk profile of the Congress Fund from least risk to the same risk profile as the Permanent Fund, since this money will be invested for over 10 years. The report listed each of the funds (Life Membership Fund, Education Fund, Permanent Fund, 2019 Congress Fund, and Unallocated Fund), the purpose of the fund, the asset mix, the target and actual allocations, and the account risk profile.

Chairman John Dodd, and Vice-Chairmen Kent Gregory and Stephen Renouf presented the Report of the Congress Planning Committee. John Dodd reported that the Congress was very successful. Kent Gregory reported on the 87 volunteers who made it run smoothly. Stephen Renouf reported that we had \$84,916 available for the Congress, which included almost \$33k raised by the Ladies Auxiliary. We expended \$71,822 on the Congress, leaving a balance for future congresses of \$13,094.

Chancellor John Dodd reported that chapters need to do due diligence to ensure all their life members are still living. At the end of the year, they should check obituaries, relatives, etc. for any life members that they cannot contact. If they are unable to make contact for two years, they need to report the life members as "inactive" to the CASSAR secretary, and we will stop paying dues for them. If they are later found, they can be reactivated; if they are found to be deceased, they can be removed from the life membership list. We need to be good stewards of the life membership fund, and should not be reducing the fund by paying the dues of deceased or missing compatriots. It was also reported that chapters were receiving phishing scam e-mails – allegedly from chapter officers – requesting gift cards to be purchased, and the card numbers e-mailed to the scammers. Please be careful, and follow-up with a phone call if the request is unusual or suspicious.

Under new business, Derek Brown discussed NSSAR demographics. The average member is aged 70-80. Most compatriots are only members for an average of 4 -5 years. We need to be better at membership retention. He suggested that CASSAR adopt the "green dot" on the name tags for first time attendees so other compatriots can be friend them, and encourage them to participate at the state and national level. Genealogist General Jim Faulkinbury mentioned that the National Society IT committee was testing corrections to the new membership module, and they will not go live with it until they are sure all the bugs are worked out.

Executive Vice President Don Littlefield reported on the audit committee, which found no issues with the financial records maintained by Treasurer Jim Klingler. He also reported on the upcoming CASSAR Annual Meeting in April 2020. The meeting will be held on April 16-18, 2020 at The Murieta Inn and Spa, 7337 Murieta Drive, Rancho Murieta, California, and the rate will be \$159 per night. This is adjacent to the Amador

Wine Country, and the Kennedy Gold Mine, which produced about \$2.4 billion in gold in today's dollars.

The ladies will have a spa day at the Murieta Inn, which is about a year old. Please book your reservations quickly before they sell out. There will be a Friday CASSAR President's Dinner at the adjacent Rancho Murieta Country Club. Don Littlefield reported that they are looking for a chapter to host the Fall 2020 Board of Managers Meeting, and they were going to check with the Redwood Empire Chapter about hosting a meeting in Rohnert Park, California. John Dodd reported on the 2020 SAR Congress in Richmond, Virginia. There is a new Civil War Museum that was done by SolidLight (the company working on the SAR Museum), so attendees will have a chance to see their work. There will be an Art Museum Tour for the ladies, and Plantation Tours on the James River. The Virginia State Capitol was designed by Thomas Jefferson, and was completed in 1788. The Richmond Marriott Downtown is almost full, so please make reservations quickly.

It was reported that the *California Compatriot* postage, formatting, and printing costs had gone up, and it is costing about \$25* for three issues. The Board of Managers voted to increase the fee from \$15 to \$25* for those that want a printed copy of the *California Compatriot* in 2020. If chapters have already collected \$15 for 2020, they will need to go back to the compatriot and ask for an additional \$10*.

Lou Carlson reported on the NSSAR 250th Anniversary Committee. From 2025 to 2083, there will be a series of 250th anniversaries to mark with ceremonies. Lou Carlson was appointed as chairman of the CASSAR 250th Anniversary Committee, and Jim Blauer, John Ferris, Dave Gilliard were appointed to the committee. [* Amended by vote of ExComm.]

The National Society is about to vote on starting work on the SAR Museum in Louisville, Kentucky. John Dodd made a motion to have CASSAR donate \$17k at the upcoming Spring Leadership Meeting, prepaying our usual \$1k annual donation for several years. The motion would be to add \$16k from the Unallocated Fund to our 2020 \$1k donation (making a total of \$17k). The motion was approved by the Board of Managers. John Dodd also reported on KYSSAR and OHSSAR giving SAR Ladies Medals to DAR members who refer members to the SAR as part of the DAR Finder program. These states get 200-300 referrals a year. John Dodd made a motion to give the DAR Medal of Appreciation for 5 referrals (with an oak leaf cluster for additional batches of 5 referrals), the Martha Washington Medal for 20 referrals, and the Daughters of Liberty Medal for 50 referrals. These medals would be presented at the DAR state meeting. The motion was approved by the Board of Managers. Stephen Renouf made a motion for CASSAR to endorse all unopposed candidates for NSSAR Office in 2020, and the motion was approved. John Dodd made a motion to endorse Lou Carlson for Chaplain General for 2020, and the motion was approved. The California Society endorsed Davis Wright for President General, Bruce Pickette for Secretary General, John Dodd for Treasurer General, Michael Elston for Chancellor General, Robert Fish for Genealogist General, Doug Collins for Registrar General, William Stone for Historian General, Tony Vets for Librarian General, Rev. Lou Carlson for Chaplain General, Joseph Dooley for SAR Foundation Board, and Darryl Addington for SAR Foundation Board. President Taylor then adjourned the meeting for lunch.

On Saturday afternoon, the Youth Awards Luncheon was emceed by Dan McKelvie, the Youth Activities Director. Following lunch, the speaker was teacher Melissa Wolking of Folsom, California, who was one of the two winners of the CASSAR Valley Forge Contest. She spoke about her trip to the Freedom's Foundation at Valley Forge, and how she could incorporate what she learned into her classroom. President Robert Taylor presented the SAR Certificate of Appreciation to Melissa Wolking for her entertaining and informative presentation. Mark Kramer presented the Silver Color Guard Medal to John Blake of the Orange County Chapter. He also presented Color Guard streamers for chapters participating in Fields of Honor and Bell Ringing color guard events. John Dodd, assisted by President General Jack Manning, presented the awards for the volunteers who staffed the 2019 Annual SAR Congress in Costa Mesa, California. It was announced that John Dodd, Kent Gregory, Stephen Renouf, and Janet Brown were presented the Silver SAR Congress Appreciation Medal at the Congress in Costa Mesa. John Dodd and Jack Manning presented the Bronze SAR Congress Appreciation Medal – those present to receive the medal were Derek Brown, Kathryn Brown (accepted by Janet Brown), Darian Taylor, Dave Gilliard, Karen Dodd, Arnie Burr, Ron Barker, Connie Barker, Don Littlefield, Brian Stephens, Diane Stephens, Jim Faulkinbury, John Ferris, Jim Fosdyck, Un Hui Fosdyck, James Klingler, Kevin Bidenkap, Karen Carlson, Leon Smith, Mark Kramer, and Steven Steinberg. President General Jack Manning presented the George Washington Endowment Fund Pin to William Nay.

Following Saturday lunch, Vice President General James Fosdyck convened the 129th meeting of the Western District. He reported that Greg Hill was working on updating the Western District Website, and there would be a link for each of the three constituent states (California, Nevada, and Hawaii) to post upcoming meetings. Charles Smith, the NSSAR Trustee for Nevada, reported that the Nevada Society Annual Meeting would be held on April 3-5, 2020 in Reno, Nevada. Kent Gregory made a motion for the Western District to endorse the same slate of national officers endorsed by the California Society, which was approved. The meeting of the Western District was adjourned.

On Saturday evening was the Saturday Gala Banquet, with Jim Klingler as emcee. President General Jack Manning brought greetings from the National Society. Following dinner, the guest speaker was the Hon. Frederick Aguirre, a retired judge on the Orange County Superior Court. Judge Aguirre was appalled at the lack of recognition of Mexican-Americans who served in the armed forces of the United States. He and his wife established the Latino Advocates for Education with a friend to highlight the service of these forgotten veterans.

This resulted in three books, a website, and a documentary film. He narrated the documentary film for us on the Mexican-American Veterans of Orange County who served in World War I, World War II, and the Korean War – including his father, Alfred Aguirre, of the US Army Air Corps, 1901st Engineer Aviation Battalion in World War II. His mother, Julia Aguirre, was a "Rosie the Riveter" at Douglas Aircraft in Long Beach. After World War II, Alfred Aguirre (who had attended segregated schools before the war) lobbied to end segregated schools in Placentia, California, and they were desegregated in 1949. Frederick Aguirre received a law degree from UCLA in 1971, and became a judge in 2002. Earlier this year, Judge Aguirre went to Normandy, France, for the 75th anniversary of D-Day, where he commemorated Mexican-American soldiers and sailors who were killed during World War II. Judge Aguirre's wife, Linda Aguirre, is a member of the Castro family of Spanish Alta California. President Robert Taylor presented Judge Aguirre with the SAR Certificate of Appreciation for his informative presentation. Color Guard Commander Mark Kramer presented the SAR Color Guard Medal to Ernie McCullough of the San Diego Chapter (a World War II veteran), and the Molly Pitcher Medal to Mary anne McCullough. President Robert Taylor presented SAR Certificates of Appreciation to those who helped with the CASSAR Meeting – Mark Torres, Brenda Torres, Spencer Torres, John Dodd, Kent Gregory, James Fosdyck, Un Hui Fosdyck, Lou Carlson, Jim Klingler, Jim Blauer, John Ferris, Liz Ferris, Dan McKelvie, Dan McMillan, Hammond Salley, Arthur Koehler, and Carmella Secrest. President Robert Taylor presented an SAR Flag Certificate to the Sonesta Hotel for properly flying the US Flag. President Robert Taylor presented the SAR Meritorious Service Medal to Mark Torres, and Kevin Bidenkap (who was not present). President Robert Taylor presented National Society Certificates of Appreciation to John Dodd (chairman of the Youth Exchange Committee, and vice chairman of the Premium Membership Medals Committee), to Stephen Renouf (chairman of the Medals & Awards Committee, and the Premium Membership Medals Committee), to Jim Faulkinbury (vice chairman of the Information Technology Committee), to Jim Klingler (chairman of the Finance Committee, and vice chairman of the Investment Committee). The rest of the story...

On November 1, 2019, the day I received the Marvelous Quilt, I recalled exactly what I was doing 50 years earlier on November 1, 1969. I was with the 3rd Marine Division at Quang Tri, Vietnam.

We were boxing up our gear in "Mout Out" boxes. On November 4th we were transported down to Danang, and then on November 7th, 1969 we were flown out of Vietnam as a unit to Okinawa. All during the time we were packing up we were under periodic rocket attacks as we were a short distance from the DMZ and the North was quite aware of our pending departure.

Thus, the Quilt is sort of a 50th Anniversary present. Your gift probably touches me more than most as I have strong feelings from those days, that remain today. I have been rated by the Veteran's Administration as 70% disabled, in part due to PTSD.

Part of my PTSD is associated directly with combat experiences; however, a part is due to the rejection and ostracization we received by both family and the community. In fact, while Karen and I have been married just short of 48 years, I was previously married and received a "Dear John" (like so many other) in Vietnam. When I returned I immersed myself in the Veteran community as they became my family.

It has only been in recent years that it has become fashionable to admit you are a Veteran.

Thank you from the bottom of my heart for your kindness and your talents. You have touched me and I am humbled by your thoughtfulness.


