144th ANNUAL SPRING MEMBERSHIP MEETING CALIFORNIA SOCIETY SONS OF THE AMERICAN REVOLUTION VENTURA, CALIFORNIA MARRIOTT HOTEL APRIL 26-27, 2019

APRIL 26, 2019 SESSION I

The meeting was opened at 9:05 am by President Derek Brown. The Invocation was given by State Chaplain Lou Carlson. The Color Guard presented the Colors. The Pledge of allegiance was led by executive Vice-President Bob Taylor. The Color Guard posted the Colors. The SAR Pledge was led by Vice-President North Don Littlefield. Due to the absence of State Secretary David L. Grinnell, State Historian Jim Blauer was asked to call the roll. (**Exhibit A**) A quorum was established.

President Brown welcomed President Scantlin on the Hawaii Society. He then introduced past state presidents who were in attendance, They are; Chuck Lampman, Bob Ebert, John Dodd, Jim Faulkinbury, Kent Gregory, Ronald Barker, Jim Fosdyck and Steve Hurst.

Remarks from National Officers included;

Ron Barker—Vice-President General of the Western District. He brought greetings from the Western District. He attended the Nevada Society meeting. There was an award, a certificate of Appreciation presented to the Department of Defense and he presented pins to veterans.

Jim Faulkinbury—**Genealogist General**. He brought greetings from National. He reported that 10% of applications are pended. Most are simple corrections, but is time consuming for National. Chapter Registrars need to double check the applications. He reported one in 5 states is entering linages of members digitally.

John Thornhill—Historian General will be here later.

John Dodd—**Foundation Board Member**. He reported that Jim Faulkinbury will be one of the 2019 Class of Minute Men. They are going ahead building out the Museum and education center. They need to raise \$780,000. They are planning on the buy a brick promotion. There is to be an article in the SAR Magazine on updating us on the happenings in Louisville. They are working on a roof expansion in hopes that they will be able to rent it out for parties. Professors have been selected and sent over to King's College to work on the papers of George III.

There is a plan to place an ad in the local Orange County Register to promote the society and its work to the public each week prior to the Congress in June. This in an effort to obtain donations from the public and foundations to help offset the cost to finish the CAAH in Louisville. They are hoping to have internet based educational programs. They would also like to get charitable Estate Planning to help in the funding. This is a long term project in which we may not see the results for 10-20 years. The foundation would like to have National Circulation in newspapers to try and raise money.

Lou Carlson—Foundation Board Member noted he was honored to be a part of the board. He urged SAR members to give via their estates.

Jim Fosdyck—George Washington Endowment Fund. He noted the banner at the front of the room. This is available to members and family members in an effort to raise money for underfunded projects. Items that are not budgeted. Examples include; Illinois needed money to fund plaques for marking graves of Revolutionary War soldiers. Louisville was funded in order to have pictures of all the Presidents General on a wall at the CAAH. The cost is \$200/year for 5

years. A total of \$1,000. This can be paid by check or credit card. Joe Dooley noted as the President of the Virginia Society, they found a black community filled with Patriots. A monument was erected listing 26 black patriots at the church in this community. John Dodd noted that this funds various projects by states and chapters. Only 4% of the funds are given out each year. The National Society Foundation website is set up to take donations. If you donate \$250 to the foundation you will then receive a CA250 pin. Ron Barker noted that members who donate to the foundation can choose where that money will be spent. Jim Fosdyck noted there were only 3 George Washington Fellows last year.

The **minutes** from the previous meeting (Fall 2018) had been mailed out and posted on line. Motion to approve the minutes was made by William Van Valkenburg. This was seconded by Douglas Bergtholdt. There were no additions or corrections and the motion passed.

Mark Kramer was asked to speak on the Screw top Powder Horn he found on-line and obtained to present to the Museum. These will be presented to the National Society at Congress in Costa Mesa.

OLD BUSINESS

The **2019 Congress** was discussed. A flyer was handed out. We are at the OC/Costa Mesa Hilton. Our block is full and Paul Callahan needs 15 or more to open up a new local hotel. The tours are being finalized. Registration will be out next month. It was emphasized that you need to register immediately. We do the staffing of volunteers and have the Host Reception to cover. The Boat being chartered for the reception holds 420-450 people. Volunteer Shirts will be handed out at the Volunteer Luncheon on Friday.

On Saturday tours will include the Lyons Air Museum and the Richard Nixon Library and the trip to the Huntington Library. The "*Hornblower*" will be the ship for the Reception's Cruise of Newport Bay.

On Sunday there will be the Color Guard Breakfast, the Laying of the wreath at Castaways Park, followed by the Memorial Service to be held at St. Andrews Presbyterian Church. Dinner will be on your own.

Monday is the opening of Congress and the minuteman Awards will be presented in the evening.

Tuesday Congress will continue and we will have Charlie Plum as out banquet speaker.

The budget for Congress looks good. The California Society is looking at \$80,000 in costs. Over \$30,000 of this total has been donated by the California Ladies Auxiliary.

Kent Gregory spoke on the Registration. Register for the luncheons Banquets and cruise. He has a list of some of the volunteers and their positions. He asks that all volunteers commit to a time and day to volunteer for a given job. Registration will close at 4pm on Saturday and will officially close for the Congress Tuesday Morning.

Jim Fosdyck spoke on the Airport Greeters. They will be in uniform only. No weapons at all. Friday is the only day.

Ron Barker is working on the Registration.

Terry Briggs reported on **Reconciliation**. It was completed back in February and March. There were 11 chapters that overpaid according to Treasurer Jim Klingler. 4 were underpaid and one is paid up so far. It was noted when reconciliations do not get in on time members get dropped. There were 60 reinstatements this year.

Jim Klingler spoke on **Chapter Insurance**. This is for non-profits. It is General Liability and Directors & Officers Insurance. It runs about \$565 per year. John Dodd noted that insurance is needed or you could be sued. Need to find a creative way to raise the money to pay for this policy.

Jim Faulkinbury had a Dues Collection proposal. The State needs to collect the dues as chapter secretaries may not understand how to do this. An Ad Hoc Committee was appointed to investigate the possibility of having the state collect the dues and not the chapter. Don Littlefield, Gary Bohannon, Jim Faulkinbury and Mark Torres were appointed by President Brown.

OLD BUSINESS

John Dodd reported that the newspaper ad we had agreed to run in the local papers before Congress was available.

The meeting was recessed at 3:11pm. We will reconvene in the morning at 9am.

SESSION III April 27,2019 The meeting was opened at 9:08am by President Derek Brown. The Invocation was given by Chaplain Lou Carlson. The Pledge of Allegiance was led by Brian Stephens. The SAR Pledge was led by Doug Bergtholdt. For the Roll call President Brown declared we had a quorum by those attendees present and those he knew were in the budget/Audit Committee meeting. It was noted that Redlands Chapter was present today.

President Brown welcomed our National officers. They included; Ron Barker, Joe Dooley, Jim Faulkinbury, John Thornhill and John Dodd.

John Dodd showed a copy of the ad they propose to run the month before the Congress in the Daily Pilot and OC Register. The OC Chapter has pledged \$1,000 to place the ad. They need \$4,000. Several members from Orange County are donating as well as Tom Adams. The donations go to the Foundation and it is tax deductible. Both Lou Carlson and John Dodd spoke on contributions to do these ads. John reported that we have just 20 Congress medals left at \$35.00.

Jim Fosdyck and Lou Carlson spoke on the George Washington Endowment Fund. It is \$200 per year for 5 years. This is to help fund projects that do not have a budget item for chapter, state or national projects.

John Thornhill thanked society for the warm welcome.

It was reported that the Vol. 4 2000-2017 of the Society History was almost complete. There is a lot of Volume 3 at National. There were 11 or 12 that desired a copy at \$25 per copy. It is hardbound.

Tanya Gillick is present from the CAR. She extended her gratitude for the support we give the CAR. She Thanked the society.

The Conflict of Interest and Whistle Blower Forms (**Exhibit**) were handed out to be signed and turned in.

Jim Klingler spoke on the raffle. In California a non-profit conducts a raffle, 90% has to go to charitable purpose. 50/50 raffles in California are illegal. He explained the Orange County Ben Franklin drawing. There are reporting requirements that must be met to the state. Registration form is one page and cost is \$20 filing fee. September 1-August 31 is the raffle revenue reporting period noting the amount raised in the report. Once registered with the state you will need to send in a yearly report. John Dodd noted all raffle monies must be used in California.

Jim Klinger reported that the Locke Award went to Redwood Empire, Gen. Patton and Orange County this year.

The Investment Fund report is in the book. As of February 28, 2019 the Life Fund has \$181,634.96. The Education Fund has \$48,581.11. The Permanent Fund has \$107,252.25. The Congress 2019 Fund has \$42,112.42. This fund will be deleted soon when our costs are paid for hosting the Congress. The Unallocated Fund has \$71,292.88. This has a speakers Fee of \$5,000. This is a \$30,000 increase over last year. The Investment Fund Trustees meet regularly with the broker.

Ron Barker spoke on the election. He noted that until a permanent replacement could be found for State Secretary, David Grinnell would temporarily do the job. Terry Briggs noted that the Genealogist was not listed in the Nomination report, though listed in the master book of reports. President Brown requested a volunteer from the floor to take over the Secretary's job. There were no volunteers. John Dodd moved that the nominations be closed. This was seconded by Lou Carlson. John Dodd moved that the slate be elected by acclamation. This was seconded by Lou Carlson. The motions passed. Phil Hinshaw asked that all chapters send this information in to the state so the names can be placed in the Compatriot in order to get a final response.

PROPOSED BY-LAWS

By Law Proposal #1 By-law 8 Section 1(b) is proposed by Fred Schuster of the Riverside Chapter. It gives a chart as to how many delegates can be had at a state meeting by the chapters. For this proposal there were no Ayes and all nays. The motion was defeated.

Proposal #2 By-Law 8 Section 1(b) is from the by-Law Committee. It leaves the number of delegates for chapters the same by notes the number will be determined by the January 1st membership count as listed in the Annual Reconciliation Report. This motion passed with only 1 Nay, all the rest ayes.

Proposal #3 By-law 8 Section 4(b)(iii) is proposed by the By-laws Committee. It specifies who is able to vote at state meetings as per Bylaw 8 Section 1(b). This proposal passed with no Nay votes.
