TRUSTEES of the CASSAR INVESTED FUNDS

CASSAR Board of Managers Meeting

April 23, 2024

The elected Trustees of the CASSAR Invested Funds are Chairman Stephen R. Renouf (2023-2026), John L. Dodd (2021-2024), and M. Kent Gregory (2022-2025). The Trustees of the Invested Funds operate under CASSAR Bylaw No. 4, Section 12.

The CASSAR Invested Funds are invested with Morgan Stanley Smith Barney (MSSB) in five separate funds: the Life Membership Fund, the Education Fund, the Permanent Fund, the Congress Fund, and the Unallocated Fund. The signers on the account are the three trustees.

The beginning value of the Invested Fund on March 1, 2023: **\$495,031.85.**

The ending value of the Invested Fund on February 28, 2024: **\$519,232.88.**

During the 12-month period described above, the total funds in the accounts increased by **\$24,201.03**. The increase was due to net realized and unrealized gains of \$49,201.03 due to a strong stock market in 2023, less \$25,000 withdrawn for donation to the SAR Foundation.

LIFE MEMBERSHIP FUND

The purpose of the Life Membership Fund is to maintain the life memberships purchased by the regular members of this society. The Fund is invested with the goal of achieving a return of 6.1% (net of fees) to cover the national, state and chapter dues for members of the CASSAR life membership program. The principal and income from this fund shall be distributed to the treasurer annually and deposited into the general funds of the society to cover the annual dues of the life members. This fund is governed by CASSAR Bylaw No. 9, Section 5.

The Permanent Fund maintains all moneys or property, real or personal, which may accrue to this society by donation, gift, devise, bequest or otherwise, unless use thereof is otherwise designated as a condition to receipt or is otherwise directed by a majority vote of the board with at least three-quarters of the members of the board present and voting. The annual income from the permanent fund shall be accumulated and one-half shall be transferred to the Unallocated Fund and one-half shall be reinvested in the Permanent Fund at the beginning of each fiscal year. This fund is governed by CASSAR Bylaw No. 9, Section 1.

RECENT ACTIVITY.

The CASSAR Annual Meeting in April 2023 approved changing from shortterm to intermediate and long-term bonds when the time was right to take advantage of the higher rates, and the Advisor will contact the Trustees to make the change when the yield curve flattens.

On April 5, 2024, the Morgan Stanley Advisor reported: "Looking at the performance, 4th Quarter of 2023, and the 1st Quarter of 2024 was good, as the report shows. At this time, I am not recommending any changes to the allocation. As we discussed last year, the portfolios are overweight short-term bonds vs. intermediate/long term bonds. During 2023, and into the new year, the yield curve has remained persistently inverted. While in the long run, I would like to make the changes to the fixed income allocations that were approved by the board last year, it does not make sense to me to increase the risk in the portfolios by adding duration to the fixed income allocations, when the shorter term bonds are paying us higher yields. I will be in touch with the trustees at the end of this month to schedule a call to review these portfolios."

Trustee Management.

Your Trustees have continued their tripartite management style and are continuing to act cautiously in management of the Invested Fund. Accordingly, the Trustees will continue to move forward with moderate to conservative management in the best interests of the Society.

Trustees' Statement.

The trustees reiterate their pledge to the membership that their activities and management of the CASSAR Invested Fund will be transparent to the membership. No actions will or have been taken by the present Trustees without the full participation of all Trustees.

California Society State Secretary's Annual Report January 1, 2022 - December 31, 2023

As the California State Society Secretary, The Year of 2023 was met with alot of Challenges resulting in great success. The State saw gains in membership, as other States saw losses. California started with 1,616 members and gained 10 New Members; making the Total Active Membership for 2023 at 1,626.

During 2023, the state secretary processed a total of 328 different transactions which brought the states total membership to 1,626 members. By December 31, 2023. The state had six (6) members transfer into the state, and nine (9) members transfer out of the state. The state had Thirty Three (33) members pass in 2023 with Twenty-Nine (29) active members reported. The state society had fifty-four (54) members reinstate their membership for the year. From April 16, 2023 through March 4, 2024, I as CASSAR Registrar have received and reviewed a total of **290** applications received from **22** CASSAR Chapters; all chapters except Riverside and Santa Barbara. Of these applications 290, **254** applications (**174** new member, Junior member and memorial applications plus **80** supplemental patriot ancestor applications) were forwarded to the NSSAR for NSSAR review, **36** applications submitted by myself to the NSSAR for review, **132** have completed NSSAR review and of these, **130** have been approved. **12** were pended/disapproved. **10 of the 12** pended applications have already been resolved and approved.

From January 1, 2023 through April 15, 2023 the CASSAR Registrar received and reviewed a total of **48** applications consisting of **33** new member, Junior member and memorial applications plus **15** supplemental patriot ancestor applications.

Upon taking office as CASSAR Registrar on April 15, 2023 the CASSAR pended applications list included 34 pended applications. Significant effort on the behalf of myself as CASSAR Registrar, the chapter Registrars and the applicants since April 15, 2023 has reduced the current number of applications on the CASSAR pended applications list to 16 pended applications (7 new member applications and **8** supplemental patriot ancestor applications and **1** memorial application). Of the 16 current pended CASSAR applications, 14 were pended before I took office as CASSAR Registrar on April 15, 2023. I prepare and provide a weekly update to CASSAR officers on the number and status of pended applications and new applications received during each week.

In addition to receiving, reviewing and forwarding CASSAR applications to the NSSAR for NSSAR review, as CASSAR Registrar I have been providing, upon request of chapter Registrars, preliminary application reviews and guidance relative to those applications prior to applications being finalized and printed for applicant and sponsors' signatures. My reviews and guidance are shared with the CASSAR Genealogist. The CASSAR Registrar and CASSAR Genealogist communicate with each other to carry-out our duties.

As CASSAR Registrar, I have also been providing information, particularly to new chapter Registrars, to guide CASSAR chapter Registrars in the performance of their duties and to present the CASSAR and NSSAR policies and standards for the preparation and submission of SAR new member and supplemental patriot ancestor applications.

The following resources guide CASSAR chapter Registrars in the performance of their Registrar duties and tasks: CASSAR Recommended Application Process, the NSSAR Application Preparation Guide (on SAR.org), the NSSAR Genealogy Committee Policies (on SAR.org), NSSAR online Registrar training videos (on SAR.org), the NSSAR Online Application Form Data Entry System (on SAR.org) and the NSSAR Patriot Research System (on SAR.org).

To the best of my knowledge at this time, two CASSAR Chapters currently are without chapter Registrars: Monterey Bay and Mother Lode. It is important for Chapters to have chapter Registrars in order to expand their membership and promote the SAR.

The CASSAR annually awards the DAR Medal of Appreciation for 5 referrals (with an oak leaf cluster for additional batches of 5 referrals), the Martha Washington Medal for 20 referrals, and the Daughters of Liberty Medal for 50 referrals. The CASSAR also annually awards a Certificate of Appreciation and cash prize of \$100.00 to the California Society DAR Chapter that provides the highest number of referrals greater than five, that result in approved SAR member applications submitted using the DAR Finder Form.

In 2022, the CASSAR received 29 DAR Finder Forms and placed 6th Nationally. Spirit of America Award Program Annual Report for 1 January to 31 December 2023

Established by the General Patton Chapter as an annual award in 1985 during the United States of America Bicentennial and endorsed by the CASSAR, the Spirit of America Award provides tangible recognition for deserving eighth grade students at their graduation ceremonies. Selected by the faculty of their school, and further evaluated by the school district, the criteria for the students is based on:

1. **Dependability** (punctuality, truthfulness, honesty, loyalty, trustworthiness and self-control at school, home and community).

2. <u>Cooperation</u> (respect for authority, property and the rights of others, and courtesy).

3. <u>Leadership</u> (ability to improve the school experience for self and others).

4. <u>Patriotism</u> (loyalty to the United States of America, knowledge of the purposes as expressed in the Preamble of the Constitution and the Declaration of Independence, and the meaning of and respect to the Flag of the United States of America).

The General George S. Patton, Jr. Chapter has presented this award annually since its inception, this year presenting awards at the graduation ceremonies for the five middle schools in the Camarillo Pleasant Valley School District.
