## Valley Forge Teacher Recognition Program Annual Report for 1 January to 31 December 2023

Intended to instill a deeper awareness of the causes and conduct of the American Revolutionary War and colonial life in America, this program is open to public and private school teachers of American history in the 5<sup>th</sup>, 8<sup>th</sup> and high school grades. Expanding on the teacher's knowledge of this period of American history, the desired result is a more-meaningful classroom experience for their students. Currently administered through the Freedoms Foundation at Valley Forge, the program utilizes resources that assist in educating students regarding the American Colonial period, the causes and effects of the American Revolutionary War, and the foundational principles associated with the establishment of the United States of America.

From the application packages of the teachers supported and assisted by the local chapters, two teachers are selected by the CASSAR committee for the tuition-paid opportunity to experience first-hand actual historical sites under the tutelage of an acknowledged historical expert. An added benefit is the opportunity to earn credit hours towards their accreditation.

## Eagle Chapter Presidents Summary

This past year we had a growth of 30 %. The chapter did not drop any members in 2024. Since the first of the year, the chapter has had two (2) members transfer their membership into the Eagle Chapter and reinstate their membership.

The chapter actively participated in the SAR 250-year program and participated in two genealogical societies (SVGS and TVSG) with 250-year SAR anniversary exhibits with Color Guard at each event. The chapter, participated in one Massing of the Colors, in San Diego.

In September, the chapters color guard participated in a Constitution Day event in downtown Temecula with the Luiseno DAR. The Eagle Chapter participated in several JROTC, and presented 4 Flag certificates during the year. We had one member who graduated from the NRA black powder course. ## General Patton Chapter Summary:

For the year 2024, the General Patton Chapter saw the normal increase in membership, starting the year with a membership of 92 compatriots and rising to a total membership of 107 on 31 December with 15 new accessions and 0 reinstatements, and then dropping to 79 compatriots on 1 January 2024 after factoring in 20 drops, 1 death, 1 resignation and 2 transfers out. Chapter meetings were held every month in 2023. The meetings were held in-person with a luncheon on the second Friday of the month at the Poinsettia Pavilion in Ventura; in March, the venue changed to Black Bear Diner in Ventura. Attendance varied from a high of 24 to a low of 9, with the average being 15, or 14.4% of the total membership, including those living outside the local area. Guests varied from 2 to 6, On a more somber note, the chapter lost one member, Ken Lynch passing away in July.

## Thomas Jefferson Chapter Summary:

The past year, the Thomas Jefferson Chapter had a net loss of 1 member, decreasing our total membership to 127 members for the coming year (including 3 dual members). We had a number of interesting speakers at our monthly meetings in 2023. In addition to the live meetings, the chapter also offered concurrent Zoom Meetings to give members living outside the area an opportunity to attend chapter meetings. In January, Jason Giamo, who leads the Young American Patriots Fife & Drum Corps, discussed the colonialera children's parade band, which is dedicated to perpetuating the music, history and heritage of our nation's founding. Jason brought two members, Fifer Jyothi Vema and Drummer Rishab Burli, and the three of them played several patriotic songs of the colonial and revolutionary eras, and explained the meanings of the songs. CASSAR Vice President North Don Littlefield swore in the 2023 chapter officers. In February, Chris Farris of Team River Run (TRR) discussed how TRR was founded in 2004 by a small group of kayakers to help veterans with physical and mental issues. In March, Major Sidney Johnson (USA-Ret.) discussed his experiences during the Korean War. In April, Vice President General (Western District) Derek Brown discussed SAR meetings and events at the state, district and national levels. He discussed the George Washington Fellow program, the SAR Education Center and Museum, and the America 250 Medal. In May, Steve Minniear, an author and historian of the Dublin and Tri-Valley area, discussed his upcoming book on the history of the Alameda County Sheriff's Department, from its founding in 1853 through the tumult of the 1960's.

After the summer recess, in September, Vice President General (Western District) Derek Brown reported on the 2023 SAR Annual Congress in Orlando, Florida, and discussed seven goals for the SAR in the next five years. In October, President Michael Hennehane discussed the Treasure Island Museum, and the history of Treasure Island, from the 1939-40 Golden Gate International Exposition, to World War II, to the decommissioning of Treasure Island NAS in 1997. In November, Dr. James Armstead, a professor of strategy and international law at the US Naval War College, spoke about the War in Ukraine, and the recent War in Israel. He gave a background of the wars, strategies used by the belligerents, and possible solutions to end the conflicts.
